Chesterfield Borough Council's Development and Growth Manager submitted a report detailing the current financial position of BCN at the end of March 2016. The report also outlined the progress that had been made towards implementing a Derbyshire-wide Building Control Partnership.

It was reported that BCN had continued to perform well financially and had achieved a reduction in authority contributions of around 22%. The new Derbyshire-wide business was expected to be launched early June 2016 however a response from Derbyshire County Council on maintaining pension arrangements was still outstanding.
