1.0 **APPLICATION**

- 1.1 The Applicant is Daniel Thwaites PLC.
- 1.2 The premise is

The Ark Tavern Chesterfield Road

Brimington Chesterfield S43 1AD

2.0 **PURPOSE OF REPORT**

- 2.1 For Members to determine an application for a variation of the premises licence in respect of The Ark Tavern.
- 2.2 Relevant representations have been made and not withdrawn and thus the application cannot be granted or refused under officer delegated authority.

3.0 CHANGES SOUGHT IN APPLICATION

3.1 The premises are currently licensed for the sale by retail of alcohol, the playing of live and recorded music and the provision of late night refreshment as below.

The sale by retail of alcohol for consumption ON and OFF the premises

- Monday to Saturday, other than Christmas Day, Good Friday or New Year's Eve, 23.00 to 23.30
- On New Year's Eve, from 23.00 to 05.00 the following day.

• Monday to Sunday 11:00 - 00:00

With non-standard timings of

- 11.00 to 02.00 on 24th, 26th, 27th and 28th December.
- 11.00 on New Year's Eve to 01.00 on 2nd January

With the same non-standard timings of

- 24th, 26th, 27th and 28th December from 11.00 until 02.30 the following day.
- New Year's Eve from 11.00 on 31st December until 01.30 on 2nd January.
- 3.2 This variation application has been subject to amendment. The initial application sought to
 - Remove some conditions from the licence and add some stronger control measures in respect of the licensing objective of "protection of children from harm".
 - Extend the current late night refreshment provision permitted in the premises licence.
 - Amend the non-standard timing for the premises opening hours.
 - Make internal changes to the premises layout which consists primarily of the removal of two low walls to open up the performance area within the premises. The entrance and lobby and rear porch which are noise control measures remained unchanged. The changes were shown on a plan submitted with the application.
 - A further impact of the plan was that if granted it would make changes to licensable activities at the premises. The plan showed an extension to the permitted area for the sale and supply of alcohol to include the rear porch and an area outside the rear doors of the premises, although this change to alcohol provision was not indicated at page 3 of the application form. That outside area has since been removed from the application by a later submission of an amended plan.
- 3.3 The proposed changes to the licence conditions are shown below. Removal of the following conditions
 - All members of staff concerned with sales of alcohol will be trained in relation to sales of alcohol to persons under the age of 18 years. (Mentioned twice).
 - Pre-opening safety checks will be carried out at the premises before each trading session.
 - Annual testing and inspection of the Gas installation at the premises by a qualified engineer.
 - Annual testing and inspection of the Emergency Lighting at the premises by a qualified engineer.

- Annual testing and inspection of the Fire Alarm at the premises by a qualified engineer.
- All escape routes and exits maintained so as not to cause hindrance in the event of evacuation.
- No persons under the age of eighteen years shall be permitted to remain on the premises after 21.00.

Addition of the following conditions in the "protection of children from harm" section

- A "Challenge 25" policy shall be adopted and enforced at the premises whereby any person who appears to be under the age of 25 shall be required to provide identification to prove that they are over the age of 18 before they are permitted to purchase alcohol. The only forms of acceptable identification will be:
 - A passport;
 - A UK Photocard Driving Licence;
 - Official ID card issued by HM Forces or EU bearing a photograph and the date of birth of the holder;
 - Any other form of identification agreed with a representative of the Police Licensing Unit.
- All staff who are involved in the sale of alcohol will be trained in relation to the "Challenge 25" policy upon the commencement of their employment, following which they will undertake refresher training at suitable intervals.
- Said training will be documented and will be made available to an authorised officer upon request.
- No person under the age of eighteen years shall be permitted to remain on premises after 22.00.
- 3.4 The application seeks indoor late night refreshment to be added to the licence as below

Mon, Tues, Wed, & Thursday
 Friday, Saturday and Sunday
 23:00 - 00:30
 23:00 - 02:30

With non-standard timings of

- 24th, 26th, 27th and 28th December from 23.00 until 02.30 the following day.
- New Year's Eve from 23.00 on 31st December until 02.30 on 2nd January.

- 3.5 An amendment to the non-standard timings for opening hours is sought as below
 - 24th, 26th, 27th and 28th December from 11.00 until 02.30 the following day.
 - New Year's Eve from 11.00 on 31st December until 02.30 on 2nd January.
- 3.6 In relation to the extension of the permitted alcohol sale and supply area, it was not readily apparent from the application that this was being sought.

The fact that a full variation application was submitted rather than a minor one led to further enquiry where it became apparent that the new premises plan had included the additional outside area for the sale and supply of alcohol.

A conversation with the Designated Premises Supervisor Mr Walker confirmed that the intention of said extension was to enable a bar to be used in the beer garden.

This would provide a better service to those customers using the beer garden, allowing not only the sale of alcohol but also light refreshment and confectionary.

The intention was to use this facility primarily in the daytime and early evening of trading hours.

4 APPLICATION PROCESS

- 4.1 A copy of the application form and associated plans can be seen at Appendix 1.
 - The initial date of receipt was 1st June 2018 but the 28 day application consultation period did not actually commence until 5th June 2018 due to site notices not being available at the premises for display.
- 4.2 The current Premises Licence is attached as Appendix 2.
- 4.3 Applications for variation of Premises Licences are required to be advertised by way of site notice displayed at the premises, an advert in the local press, and copies of the application submitted to all Responsible Authorities.
- 4.4 A copy of the appropriate local press advert taken from the Derbyshire Times on Thursday 14th June 2018 is attached at Appendix 3.

- 4.5 The site notices displayed on the premises, advertising the application were viewed by licensing enforcement staff on 7th June 2018 and found to be displayed correctly and completed appropriately.
- 4.6 The application was submitted by e-mail. Consistent with current guidance, the Chesterfield Borough Council Licensing Authority circulated a copy of the application to the Responsible Authorities within the appropriate time limits.
- 4.7 The statutory deadline for representations in respect of the application was midnight on Monday 2nd July 2018.
- 4.8 Responsible Authorities and Interested Parties (persons/bodies representative of businesses or residents in the vicinity of the premises) are entitled to make representations to the Licensing Authority provided they are relevant representations.
- 4.9 A number of representations have been received and accepted, in relation to one or more of the licensing objectives which are:-
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - protection of children from harm
- 4.10 The representations come from local residents and two responsible authorities which are Chesterfield Borough Council's Environmental Health Department and Licensing Department.
- 4.11 After receipt of the first local resident representation, it became apparent that there were other residents who were dissatisfied with the application but had not submitted a representation. This was due to concerns that their input would not have any effect upon the representation process and was based upon their experiences of a previous hearing for a variation application at the same premises.
 - The current application was drawn to their attention and a further 3 representations were submitted.
- 4.12 Redacted copies of the representations are shown at Appendices numbered 4 to 9.

- 4.13 As a result of the representations received, an amended premises plan was submitted by the applicant on 10th July 2018.
- 4.14 The new plan removed the outside area from the scope of the application. It resulted in a smaller extension to the area identified for the sale and supply of alcohol, now just adding on the porch at the rear doors of the property that gives access to the beer garden.
- 4.15 A copy of the new plan can be seen at Appendix 10.

5 REPRESENTATIONS

- 5.1 Any representation received must be relevant to the likely effect of the proposed variation on the promotion of at least one of the 4 licensing objectives which are:
 - (1) the prevention of crime and disorder
 - (2) public safety
 - (3) prevention of public nuisance and
 - (4) the protection of children from harm.

Representations which are not relevant must be rejected.

- 5.2 If a representation has been made but is subsequently withdrawn it is no longer a relevant representation and provided there are no other relevant representations the application can be dealt with under officer delegated authority.
- 5.3 The representations that have been made address all four licensing objectives to varying degrees.
- 5.4 Upon receipt of the amended plan, the changes were brought to the attention of those making representations and it was found that none of the representations were withdrawn.
- 5.5 The Licensing Authority considered the application and representations in light of the amended plan that was submitted, determining that the representations remained relevant.

- 5.6 This determination was reached after taking account of section 8.57 of The Secretary of State's Revised Guidance issued under section 182 of the Licensing Act 2003.
 - 8.57 The licensing authority must also consider any relevant representations received from other persons within the time limit referred to below. As stated earlier in this Guidance, representations are only relevant if they clearly relate to the likely effect of the grant of the variation on the promotion of at least one of the licensing objectives; representations must be confined to the subject matter of the variation. In the case of minor variations, there is no right to a hearing (as for a full variation or new application), but licensing authorities must take any representations into account in arriving at a decision.
- 5.7 The intention of the changes at the venue appears to promote the live music aspect of the premises, making the main performance area within the premises more accessible.
- 5.8 The venue advertises itself as "The Home of Live Music" and has a number of enthusiastic followers. Appendix 11 shows a small selection of Facebook page screenshots which appear to support this.
- 5.9 As the representations made relate to the performance of live music at the venue they were deemed relevant.

5.10 Local residents

The representations that have been made by local residents identify the following issues:

- Live music played at exceptionally loud volumes, which leak straight out from the pub.
- Very loud music on bank holidays.
- Music going on until late at night, disturbing the sleep of residents.
- Shutters not used during live performances.
- Windows remain open during live performances.
- Doors open during live performances.
- Teenagers congregating in and around the Ark Tavern, exhibiting anti-social behaviour.

- Observation of teenagers present in the beer garden and leaving the premises after the 21.00 curfew stated for under 18 year olds. These often look to be in a state of inebriation and cause nuisance in and around the premises and road.
- Failure to adhere to current licence conditions, in particular the beer garden being used for consumption after the 2300 curfew for that area.
- Unruly behaviour of unsupervised children using the beer garden including footballs repeatedly kicked into neighbouring gardens.
- The children's climbing frame in the beer garden which is tall enough to allow users to look into neighbouring gardens and its unsupervised use (ostensibly a planning issue which cannot be addressed through planning legislation due to the length of time it has been in situ).
- Scuffles and fights outside the public house.
- Very late departure of customers from the public house with shouting, swearing and walking in the road, taxis pulling up outside sounding their horns.
- Failure to adhere to previously agreed conditions between residents and the premises which included
 - Music would be stopped at 23.00 on Tuesdays
 - o Placing soundproof boards at windows
 - o Keeping doors closed
- Inability of residents to enjoy their own homes and gardens as noise from the Ark Tavern intrudes.
- Disappointment at the way the last variation application for the premises was dealt with.

The representations need to be read to get a better appreciation of the impact of the premises upon the local residents.

5.11 <u>Licensing Authority</u>

The Licensing Authority representation addresses a lack of adherence to current licence conditions, specifically the beer garden curfew.

It was disappointing to see a repetition of this failure after the issue had been previously discussed with the premises management.

5.12 Environmental Health

The Environmental Health Department representation centres on the fact that there are ongoing investigations into noise complaints at this premises and similar historic complaints. The Senior Environmental Health Officer Mrs Thelwell asked the premises licence holder to complete a noise management plan but this has not been completed to date. Nor has the public nuisance section of the variation application form which would indicate what measures are being taken to address any noise issues.

5.13 Video Footage

In addition to the written representations accompanying this report, there are a number of video clips compiled by one of the representors showing offending behaviour at the Ark Tavern. These are provided on two DVD discs.

There is a summary of the video content provided on the first disc which is included at Appendix 12. This disc has 29 video clips recorded between 1st April 2018 and 1st July 2018. There is some overlap in the described type of behaviour recorded. In summary, it states that the following can be seen

- 19 incidents of loud music
- 6 incidents of use of the beer garden after 2300, accompanied by alcohol consumption and loud music
- 3 incidents of nuisance behaviour of children
- 1 incident of the rear porch doors remaining open at the premises allowing music escape

Of these incidents, 8 are recorded after 2300.

5.14 A supplementary disc has been produced with a further 10 video clips thereon.

Again, there is some overlap in the described type of behaviour recorded. In summary, the following can be seen

- 1 incident of loud music
- 4 incidents of use of the beer garden after 2300, accompanied by alcohol consumption and loud music
- 2 incidents of loud, unruly behaviour in the rear garden including one of nuisance behaviour of children
- 1 incident of the rear porch doors remaining open at the premises allowing music escape

Of these incidents, 9 are recorded after 2300.

- 5.15 Some of this video footage appears to show breaches of the conditions on the licence as below
 - The beer garden will cease to be used by customers for the purposes of the consumption of alcohol at 23.00 each day.
 - The management will ensure that the grounds of the premises will be kept tidy and without nuisance to other neighbouring businesses or residents.

This video footage will be made available to the Licensing Committee to view.

- 5.16 Taking into account multiple recordings during single trading sessions the video content can be summarised as below.
 - 39 separate recordings made between 1st April and 1st July 2018.
 - 20 separate trading sessions are subject of video recordings
 - Noise nuisance, late use of the beer garden, alcohol consumption in the beer garden after 23.00 and unruly, inconsiderate behaviour of patrons is common.
- 5.17 A further chronological summary has been produced combining the original document and the later disc content, to show all the incidents grouped by date and this is shown at appendix 13.
- 5.18 The below table shows a selection of those video clips representing different sorts of behaviours at the premises.
- 5.19 These video clips are available to be viewed now by the committee should they wish to see behaviour complained of.

5.21 The allegation of use of the beer garden after curfew is supported by an observation visit by the Licensing Department's enforcement patrol at 23.52 on Saturday 23rd June 2018 where some 8 or 9 patrons were seen in the beer garden of which 3 were drinking alcohol.

A further visit 10 minutes later found some of this group had left but that 2 were still drinking alcohol.

At this time 2 males were observed to urinate against an outhouse near to the car park.

5.22 This sort of activity had already been discussed previously with the premises management on 2nd June 2018. The issue of the breach of this condition had been raised on that enforcement visit as a result of a complaint that had been received in relation to Bank Holiday activity at the premises.

It was explained that the management had been let down by a staff member in relation to that complaint. He had been away from the premises on that occasion and the staff member had failed to monitor keeping doors closed or use of the beer garden later in the evening.

However between the content of the discs viewed to date and the enforcement visit findings, it appears to indicate there are a further

- 5 trading sessions after this issue was raised, when the same offending behaviour has been repeated.
- 5.23 It is fair to say that had this video evidence been presented in isolation and not in the context of this variation application, it would lead to separate proceedings against the premises.
- 5.24 In investigating this application the following information has also been gathered
 - Neither Derbyshire Police nor the Chesterfield Borough Council Community Safety Department have any incidents of antisocial behaviour logged against the premises over the last 12 months.
 - Chesterfield Borough Council's Environmental Health Department has a number of ongoing and historical complaints lodged against the premises in relation to noise and nuisance.

6.0 ADDITIONAL INFORMATION

- 6.1 The Ark Tavern has experienced some success with the introduction of live entertainment at the venue on weekend evenings and at a "jam night" on Tuesday evenings. Whilst increased footfall and patronage have been popular with the premises and staff, local residents are not so happy about the change in emphasis at the premises which they describe as "village public house to live rock music venue".
- 6.2 Clearly the issues of noise nuisance and disorderly conduct are ones that local residents associate with the premises and are contentious for those living nearer to the premises, as evidenced by the representations made.
- The same premise was subject to a previous variation application in March 2017.
 This resulted in the application being heard before the Licensing Committee in May 2017.
 On that occasion permission for live music was granted to the
 - On that occasion permission for live music was granted to the premises to allow live music within the premises daily from 1100 to midnight.
- 6.4 That application was also opposed, with representations tendered by six local residences.

- Ultimately, the application was granted and the decision letter for that Licensing Committee Hearing can be seen at Appendix 14.
- 6.5 The residents who attended the previous hearing state that on that occasion the Designated premises supervisor voluntarily agreed with them to employ the noise reduction tactics referenced in the representations i.e.
 - Music would stop at 23.00 on Tuesdays
 - Placing soundproof boards at windows for live music performances
 - Keeping doors closed during live music performances.
- 6.6 There is reference in the current representations that as soon as the last variation was granted, these measures were no longer employed on a regular basis.
- 6.7 The representors feel that their representations were not given due weight on that last occasion and so felt let down by the result of that committee. They are understandably sceptical about the value of this hearing and some were reluctant contributors to the process.

7 OPTIONS

7.1 <u>Determination of application</u>

When carrying out its licensing functions, the Licensing Authority must do so with a view to promoting the 4 licensing objectives and also with regard to its Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Licensing Act 2003.

- 7.2 The Licensing Committee may grant the application as requested, grant it subject to conditions, or refuse the application.
- 7.3 Where either the applicant or a person who made relevant representations is aggrieved by the decision of the Licensing Authority, appeal is to the Magistrates' Court.
- 7.4 Should the committee choose to grant the application with modified conditions then based on enquiries with those making representations, some of the following might be found to be acceptable
 - · Removal of live music as a permissible activity

- A reduction in the terminal permissible hour for live music performances at the venue
- The addition (as conditions to the licence) of the noise reduction measures mentioned as having been previously negotiated i.e.
 - Music would stop at 23.00 on Tuesday's jam night
 - Placing soundproof boards at windows for live music performances
 - Keeping doors closed during live music performances.
- A reduction in the terminal permitted hour for use of the beer garden, irrespective of whether consuming alcohol or not.
- The addition of a licence condition requiring the completion of a noise management plan which would need Environmental Health Department approval for implementation and subsequent amendment.

8 RECOMMENDATION

8.1 That the Committee

- consider the representations made by local residents and Responsible Authorities and
- Determine whether the application for a variation of a Premises Licence made by Daniel Thwaites PLC for The Ark Tavern be granted, granted with conditions, or refused.





- o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- (b) customers are made aware of the availability of these measures; and
- (c) that these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (d) staff must make customers aware of the availability of small measures when customers ask for a drink without specifying the size.

PUBLIC NUISANCE

My house backs onto the Ark Tavern and this has been a continual source of Noise nulsance for many years. And subject to many complaints by myself and other residents.

This eased when the licensees partner Vyda got involved as she gave me her number and if I called she would make sure all the exterior doors were kept shut, the noise reducing shutters were on the windows and the band sound levels were monitored.

This changed totally around three months ago, the band noise levels increased to such a level that I have been videoing them from the bottom of my drive which is over 300 meters away and the music can still be heard, this is made worse by the fact the only music they play is rock music so you can constantly hear the thump thump of the drums. This was brought to a head when I invited family around for a BBQ on a bank holiday Monday 7th May, and the bands started at around 330 pm and the music was incredibly loud, I waited till around 530 by which time I had had enough and walked round to see why the noise was so loud to find none of the noise reducing levels were being used. No shutters were to the windows and all the doors leading out side were wedged wide open! I asked the licensee repeatedly to close the doors and the answer I got was "sorry the music is so loud I cannot hear you "

I received a phone call from Vyda the other day to apologise for the problems I was having and to explain it was through no fault of hers as she had now split with Richard so no one was monitoring the noise.

Noise from live bands in the ark tavern is a constant problem due to the door from the main property to the beer garden being opened to access the beer garden and in a lot of cases wedged open to allow noise out of the property.

The addition of an outside bar in the beer garden of the Ark Tavern will increase the amount of people coming out of the back doors to get to the outside bar to avoid queuing in the main bar, causing even more noise to leave the property than we experience now (this is already following a formal complaint to licencing and Environmental Health departments with the council as well as the local Parish Council)

The Ark Tavern already has a stipulation in the licence that no alcohol can be consumed in the beer garden after 11pm. This is another Formal complaint that I have lodge as they are drinking and shouting in the beer garden well up

to midnight most weekends and Tuesday nights when the bands are on. This has also been videoed and passed to the licencing officer Mr Steve Ashby

I do not believe they are following the licencing agreement as it is, so allowing them further alterations does not seem the best course of action when they cannot manage the premises on the basis it is at the moment.

The noise generated from the beer garden and the play area already causes a noise nuisance without attracting more people to use it.

There is a play area situated right behind my hedge where children are simply DUMPED NOT MONITORED to play while their parents are drinking at the top of the beer garden (again id guess at another Licencing breach)

The play area has a climbing/play castle were the children sit around 6 feet off the ground screaming and shouting (with solid earth below in the summer, there is no soft area in case of falling). It is like living next door to a school yard not a public house beer garden!!!!!

Once on this structure they can sit happily looking directly over my back garden loosing all the privacy I'm sure I am entitled to.

Or playing football which again is not monitored as can clearly be seen with the amount of time the balls come over onto my garden hitting my conservatory and the constant boom boom as the ball is kicked.

Again any alteration to attract people into this outside area will only make all these issues worse.

As a recap, I have children screaming and shouting and looking over my garden in the day time till around 8pm from the beer garden which might as well be a children's park or play ground apart from the fact it is not safe rather than its original use as a beer garden. Then once they go the music starts till around 12pm which includes all the shouting and cheering from the beer garden.

There are multiple breaches to the licence that is already in place so I do not think any increase or alteration to this should be considered. If anything I would like to see the licence re assessed with respect to the above issues so they can be resolved.

Lastly I am away from the 14/7/18 till the 29/7/18 and I would appreciate it if the hearing was before or after that date as I would like to attend to present my case as I am massively effected by any change to the Ark Tavern and I could not attend the last one for the late licence extension for music till 12pm which again has had a big impact on my quality of life and lead to nuisance complaints to both Licencing and Environmental Services.

Hi Steve.

As discussed, I have concerns with this variation application.

I am currently investigating complaints about noise from the venue. The complainant informs me that noise levels are exacerbated when the venue hosts an event and the doors leading from the beer garden are continually opened and closed, or occasionally, left permanently open – allowing music to escape the building. Another source of noise is from customers using the beer garden, particularly late at night.

Due to the ongoing noise complaints I have asked the premises licence holder to complete a noise management plan – I am awaiting receipt of this.

Section M(d) of the application form provides space for the applicant to write down any additional steps that will 'prevent public nuisance'. On the application form this space is left blank. I am unsure how noise from this proposal will be minimised/prevented/managed.

Until further information is received to support section M(d), I cannot agree to the variation application.



I have frequently observed teenagers both in the beer garden and coming from the front doors after both of these times. Often these teenagers look to be in a state of inebriation and cause a nuisance around the premises and on the road.
This application to serve alcohol into the early hours of the morning each day of the week seems completely out of character for a small village pub in a conservation area and unjustifiable when viewed with the other issues that are caused by the Ark Tavern.

After the last application to extend the hours was made and granted we as residents who live very close to the premises felt very let down and disappointed the we didn't seem to be considered at all and although I understand the law must be applied but surely, we should have been considered somewhere in the process. We are not unreasonable and do appreciate the landlord has to make a living but surely it should not be at our expense and he should be willing to compromise a little.

After the last licence was granted the landlord did agree with one of the residents that he would stop the music at 11pm on Tuesdays but that doesn't happen, and it continues well after that time every week.


As I suspected all the measures he was taking like putting sound proofing boards up to the windows and keeping the doors closed has stopped now he has got the extended licence he doesn't even try to keep the noise down to acceptable levels.

An extra outside bar at the rear of the premises would cause even more of a problem with customers being able to buy drink directly from an outside bar which will then lead to more people being outside and the more people that are outside the more noise there will be There are customers outside after the permitted 11pm now which is in breach of the existing licence so as with the sound proofing once the outside bar has been given a licence the noise levels will be even more and the rowdy, drunken customers will just move outside. If the weather is good most people will be outside so that is then a reason to try and move the live music outside also.

We have lived here for 25 years and this a real problem to us as we cannot sit in our garden at weekends when bands are on or stay at home at Bank Holidays especially like the next one coming up there will be 10 bands playing on Sunday the 26th August throughout the day and so we are planning to go out all day as it is impossible to stay home unless you are a HEAVY ROCK fan.

In conclusion allowing a bar to be erected at the rear of the Ark Tavern will not only create more noise and anti-social behaviour every weekend and bank holidays, my biggest fear is that it will then lead to another application for live music outside because they have an outside bar. I do think that this is the first step towards that happening. The applicant is obviously only interested in making money and has absolutely no consideration for his neighbours.

It seems to me that the applicant is trying to turn a small village pub into a HEAVY ROCK music venue.

Thank you for providing the information regarding the new application made by the Ark Tavern. I was totally unaware of this and I am sending this by direct email to ensure that it meets the required timescale.

I would like to make representations under The Prevention of Public Nuisance

The building of an outside bar would create additional noise nuisance and I object to this strongly as we are already subjected to excessive noise pollution from this public house which is well beyond that created by the other local pubs. I must also point out that the Landlord is not complying with his current licencing conditions in that outside drinking continues beyond 23:00 and the addition of an outside bar is likely to make this worse.

As one of the two local residents who attended the previous hearing, I am aware of the mitigation measures that the landlord advised those present that he would be using. I can confirm that he is not using these on all occasions that there is live music and the sound proof shutters are not being used and doors are being left open. Residents have had to made requests directly to him for the shutters to be put up and the doors to be closed when bands are playing.

In the current period of high temperatures I am not able to have my upstairs windows open in the evening / night because he is not using the mitigation measures and music is so loud that I am unable to sleep. As stated last time, my grandchildren are also adversely affected by this when they visit.

The Landlord has yet again not engaged with his neighbours regarding this new application and I consider that this is evidence of his ongoing disregard of those that his premises adversely affects.

In summary, the Landlord appears to not be vigilant in complying with his current licencing restrictions or the mitigation measures that he advised the committee at the last hearing that he would introduce and use every time that he staged live music.

I hope to attend the hearing regarding this new application, although presumably he will have legal representation again, which appeared to be more valued more by the licencing committee than the ordinary people that would be affected by the changes that they agreed.

Clearly based of the previous experience, I am not expecting that the views of the residents will carry much weight, but hopefully more people may be willing to attend than last time.

Could you please advise what date has been set for the hearing.

Thanks again to bringing this to our attention and I look forward to seeing you at the hearing.

The Ark Tavern is a premise on Chesterfield Road, Brimington, Chesterfield, Derbyshire, S43 1AD.

The premises licence permits the following licensable activities.

- any playing of recorded music
- the sale by retail of alcohol
- provision of late night refreshment
- a performance of live music

In March 2017the premises was subject to a minor variation which extended the terminal hour performances of live music from 2300 hours to midnight.

This application attracted a number of representations from local residents and was eventually heard before Chesterfield Borough Council's Licensing Committee in May 2017.

After deliberation, the variation was granted as requested.

We now have a further variation application submitted in June 2018, which seeks to extend the area where the sale and supply of alcohol is permitted. The additional area extends from the beer garden doors at the rear of the premises and encompasses a wooden bar structure adjacent to the rear wall of the property within the beer garden.

Chesterfield Borough Council's licensing department objects to this application under the licensing objectives of


- prevention of public nuisance and
- prevention of crime and disorder

for the following reasons.


- 1. The additional area requested would benefit from the current hours permitted for the sale and supply of alcohol i.e.
 - a. 1100 am to midnight Monday to Thursday and

- b. 1100 am to 0200 am Friday and Saturday.
- 2. There are already several instances of complaints of noise nuisance associated with the premises both outside and within. Extending the capacity to sell alcohol outdoors will not assist in addressing these matters.
- 3. There are also complaints of breaches of the licence conditions particularly:
 - a. The beer garden will cease to be used by customers for the purposes of the consumption of alcohol at 23.00 each day.
- 4. The sources for this complaint are diverse. As the premises is currently unable to meet its obligations in terms of adhering to existing license conditions, we have concerns that increasing the access to alcohol outside the premises will only add to the current level of non-compliance.


In the interests of preventing public nuisance and crime and disorder, the licensing Department is therefore unable to support the application and must make representation against it.

Decision Notice

The Council's Licensing Committee met on 18 May 2017 to consider the application made by Daniel Thwaites Plc for a variation of a premises licence in respect of The Ark Tavern Chesterfield Road, Brimington, Chesterfield.

- 1. Representations against the application (and which had not been withdrawn) had been made by interested parties.
- 2. No representations had been made by any of the Responsible Authorities against the application.
- 3. The Applicant was represented by Mr M Ireland, Solicitor. Mr R Walker (Designated Premises Supervisor at The Ark Tavern) and his partner also attended the hearing.
- 4. Mr Akhtar and Mr Fisher, two of the interested parties, attended the hearing.
- 5. The Licensing Committee considered the report which was before them and the representations which had been received (and not withdrawn) and the submissions made by Mr Ireland, Mr Akhtar and Mr Fisher at the hearing.

6. The application had been submitted for a variation of a premises licence to (1) authorise the activity of live music at the premises from 11:00 hours to midnight from Monday to Sunday; and (2) to remove three conditions from the licence.

7. Decision

- (a) That the application for a variation of a premises licence be granted as per the application submitted.
- (b) That an additional condition be added to the licence as volunteered by the Applicant in order to promote the licensing objective relating to the protection of children from harm –

"No person under the age of 18 years shall be permitted to remain on the premises after 21:00 hours."

8. Reasons for the Decision

The Licensing Committee carefully considered the report which was before them and the representations which had been received (and not withdrawn) and the submissions made.

The Licensing Committee decided not to attach any weight to the written representations from members of the public and patrons of the premises that had been made in support of the application which had been submitted by the Applicant a few days prior to the hearing as those representations had not been made within the prescribed period.

The Licensing Committee decided that the proposed variations in respect of the removal of the three conditions set out in the application were non-contentious and could be granted without undermining any of the licensing objectives.

The representations that had been made by the interested parties related to noise nuisance, parking issues and disorder.

The Committee did not consider that the representations relating to parking issues were a matter that could be considered in the context of the Licensing Act 2003. The Committee accepted the Applicant's submission that, on the facts of this particular case, parking and highways issues were matters that could be considered under planning law but not licensing law. The public safety licensing objective related to the safety of people using the premises rather than the risk to safety that may arise as a consequence of vehicles parking in the locality of the premises. The public nuisance licensing objective related to the effect of licensable activities at the premises on people who live and work in the area around the premises and this, in the Committee's view, may include noise nuisance but not parking issues.

With regard to the representations relating to disorder, the Applicant had denied that there had been any but in any event its submissions were that (a) the police had not objected to the application and (b) the addition of live music as a licensable activity was not relevant to the licensing objective of preventing crime and disorder. The Licensing Committee decided that there was no persuasive evidence before it that the premises had been

responsible for undermining the licensing objective relating to the prevention of crime and disorder. The Committee also decided it was significant that the police had not made any objection to the application and, in all the circumstances, the objections made by interested parties relating to disorder were not sufficient to refuse the application or to add any extra conditions to the licence.

The Committee considered that, in the main, the objections that had been made related to noise nuisance which, in turn, concerned the licensing objective of preventing public nuisance.

The interested parties' case was, in summary, that the premises are in close proximity to residential premises and the noise caused by bands and other performers playing music had (and is) a nuisance and the nuisance would be worse if the application was granted to allow the premises to have live music until midnight seven days a week.

The Applicant's case was, in summary, that apart from a music festival that had been held at the premises 18 months ago, which had resulted in complaints being made, there had been no issues relating to noise nuisance and live music going beyond 23:00 hours. The Applicant submitted that the works it had recently carried out at the premises had minimised noise escaping. The Applicant referred to the fact that the Environmental Protection Service had not objected to the application and to the written observations that had been made by the Environmental Health Officer. The Applicant also made reference to the judgment made by the Administrative Court in the case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court and others [2008] EWHC 838 (Admin).

The Committee was informed that there were other licensed premises in the locality that were authorised to have live music performed at their premises and some of those authorisations extended until midnight and 01:00 hours and 02:00 hours.

The Applicant submitted that its intention was, if the application was granted, to use the extended hours on Friday and Saturday nights and to continue with the "jamming" events on Thursday nights; however, the Applicant still wanted the flexibility of a licence that permitted the performance of live music until midnight on Monday to Sunday.

The report that the Licensing Officer had presented made reference to the fact that the Live Music Act 2012 automatically allowed the premises to provide live music, without requiring a licence to do so, between the hours of 08:00 and 23:00, provided that the audience did not exceed 500.

The Committee considered that whilst the interested parties had mainly based their representations on noise nuisance and it was important for licensed premises to control the levels of noise emanating from the premises there was not sufficient evidence to refuse to grant the application or to impose additional conditions. The Committee decided that the Applicant had taken reasonable steps to minimise noise escaping from the premises by carrying out the recent works. The Committee also decided it was significant that the Environmental Protection Service had not objected to the application and had carried out monitoring after the works had been carried out which had indicated a reduction of noise escaping and, in all the circumstances, the objections made by interested parties relating to noise nuisance were not sufficient to refuse the application or to add any extra conditions to the licence.

9. Rights of Appeal

The interested parties who made representations against the application may appeal against the decision to grant the application, or that on granting the application, the Licensing Authority should have imposed different or additional conditions on the licence.

Appeals must be made in writing to Northern Derbyshire Magistrates' Court, Justice Centre, Tapton Lane, Chesterfield S41 7TW, within the period of 21 days beginning with the day on which the appellant was notified by the Licensing Authority of the decision appealed against.

10. Operative date

The grant of the application takes effect on 18 May 2017.

11. Distribution of Decision Letter

This letter has been sent to the Applicant's solicitors, The Designated Premises Supervisor at the premises, Derbyshire Constabulary and to the interested parties who made representations against the application.

PROPOSED CONDITIONS

- Where such a measure would not contravene fire safety measures, self-closing arms will be fitted to external doors and to lobby doors to assist in preventing the outbreak of noise.
- > Regular supervision of external areas will be undertaken when external areas are in use and a specific member of staff will be nominated to undertake this responsibility each time the premises carries on licensable activities.
- > Signs will be erected at public exits advising customers that drinks are not permitted outside after 23:00 each evening.
- Whenever amplified regulated entertainment is hosted at the premises, the management will conduct regular assessments of the noise emanating from the premises and, where said assessments indicate that the level of noise may cause nuisance to local residents, the management will take action to remedy the level of noise. Said assessment will be documented and made available to an authorised officer upon request.
- Any amplified regulated entertainment which takes place at the premises will be channelled through a noise limiter. The noise limiter will be calibrated to such a level that the noise does not cause a nuisance to any noise sensitive properties in the vicinity.
- Whenever the premises is hosting amplified regulated entertainment, the windows and doors will be kept closed, except for the purposes of access and egress.
- Persons under the age of eighteen years will not be permitted on the premises unless accompanied by an adult.
