1. <u>DECLARATIONS OF MEMBERS' AND OFFICERS' INTERESTS</u> RELATING TO ITEMS ON THE AGENDA

No declarations were made.

2. **APOLOGIES FOR ABSENCE**

Apologies for absence were received from Councillors Bowman, Hill and Watts.

3. **MINUTES**

The notes and the Records of Decision of the Joint Board meeting held on 20th May, 2013 and the draft notes from the Joint Chief Executive's meeting held on 20th June, 2013, were noted.

4. <u>RELATIONSHIPS WITH DERBYSHIRE COUNTY COUNCIL/SHARED</u> SERVICES OPERATIONS

The Leader and the Acting Chief Executive of Derbyshire County Council attended the meeting to discuss the opportunities that might exist for future joint working with Chesterfield, North East Derbyshire and Bolsover Councils.

A discussion took place and the following suggestions were made:

- Improving Services for Older People
- New Public Health agenda
- Anti Poverty Strategy
- Health, Social Care and Housing Integration
- Economic Development
- Community Budgets
- Trading Standards and Environmental Health Services

It was agreed that a wider conversation was warranted with other Derbyshire Councils, and that the best vehicle to achieve this would be the Derby and Derbyshire Strategic Leadership Forum.

AGREED – That the comments be noted and further discussion take place at the next Derby and Derbyshire Strategic Leadership Forum.

5. TRANSFORMATION CHALLENGE GRANT BID

The Head of Business Transformation (CBC) submitted a report in respect of the Transformation Challenge Grant (Authority Award) Bid that he had recently submitted on behalf of Chesterfield Borough Council, North East Derbyshire District Council and Bolsover District Council. Ashfield District Council, Bassetlaw District Council and Mansfield District Council were also signatories to the bid.

The intention behind submitting the bid was to enable reviews to be undertaken of the current joint working arrangements across the three original authorities for Building Control (BCN) and Internal Audit, and the five authorities for Procurement.

A bid for £50,000 had been made, and the funding would be used for the following:

- To resource a project manager to lead on commissioning the work
- To undertake the procurement of competent and experienced practitioners to progress the commission.
- To undertake the individual reviews, compile reports and make appropriate recommendations to the Councils.

The bid was submitted on Friday 12th July and the outcome would be known by the end of August.

AGREED - That the Joint Board notes the bid.

6. SHARED PROCUREMENT UNIT (SPU) ISSUES UPDATE

Mr M Hill, Procurement Officer from Bassetlaw District Council, attended the meeting to give an update on the procurement service now being offered by his Council to Bolsover, North East Derbyshire, Ashfield and Mansfield Councils.

An appropriate legal agreement had been prepared and circulated for comment, and it was hoped that the necessary commitment would be in place within the next fortnight.

Procurement clinics were already being held every 2 weeks at each Council, and these were proving to be very successful.

The Chief Executive of Chesterfield Borough Council confirmed that they had stepped out of these new arrangements for the time being as there were a number of major procurement projects in need of more dedicated support, such as the rebuild of Queen's Park Sports Centre, the refurbishment of the cultural venues, and an expanded Housing Capital programme.

AGREED - That the update on the Shared Procurement Unit be noted.

7. **HS2 – UPDATE**

A discussion took place on the proposal to introduce high speed rail connectivity between London and Leeds. It was noted that a report was being considered at the Sheffield City Region LEP Board meeting later that evening.

It was noted that the Government's consultation on the proposal was due to commence on 17th July 2013 and that the 3 Councils would be asked to contribute to it. It was suggested and agreed that this needed to be approached with caution as it was important to get the right message out to members of the public.

The Chief Executive of North East Derbyshire District Council and Bolsover District Council suggested that a meeting be set up, at the appropriate time, involving Regeneration and Communications staff from the 3 Councils to decide on a form of words to put before members by way of a shared statement to the public.

AGREED – That the update be noted.

8. JOINT OVERVIEW AND SCRUTINY PANEL UPDATE

This item was deferred to the next meeting.

9. **COMMUNITY COVENANT**

The Head of Business Transformation for Chesterfield Borough Council gave an update in respect of the Community Covenant. He reported that a meeting was taking place with Derbyshire County Council on Thursday, 18th July to look at the Terms of Reference and Joint Publicity. Attendees would also be considering the timescales for submitting bids to the Ministry of Defence. And, it was noted that an evaluation panel would be set up to review the bids prior to their onward submission to the Ministry.

AGREED - That the update be noted.

10. BCN CONSULTANCY (BUILDING CONTROL)

The Head of Regeneration (CBC), the Joint Head of Regeneration (Bolsover and North East Derbyshire District Councils) and the Building and Contracts Manager (Bolsover), submitted a report to provide an update on the current budget position for BCN Consultancy (Building Control) and to advise on progress with the Options Appraisal.

- AGREED (1) That the current budget position of BCN be noted.
 - (2) That progress on the Options Appraisal be noted.

Apologies for absence were received on behalf of Angela Grundy.

CHESTERFIELD AND NORTH EAST DERBYSIRE CREDIT UNION – BUSINESS PLAN

Rachel thanked the Local Authorities for their input in the Business Plan and past support. She explained the activities of the Credit Union. Bill went through the business plan. Questions were asked in relation to the Credit Union Expansion Project (CUEP). Wes enquired if, following previous comments made, £20,000 was a realistic figure for rent. Karen said that she was currently viewing properties based on a £15,000 pa rental with separate accommodation for back office. Discussions took place based on the financial plan interest at 3%. Bill enquired if the loan from CBC of £25,000 could be turned into a grant.

Huw referred to conversations in January where he had stressed that the Credit Union could not keep going back to the District Councils for further funding, this was not a sustainable position and a business plan had been requested in order to be able to identify a point of self financing.

Huw offered the following contribution from Chesterfield Borough Council, based on the financial plan interest of 3%, subject to a formal approvals process:

13/14 - £5,000 14/15 - £10,000 15/16 - £5,000

Wes confirmed that North East Derbyshire District Council had agreed, at Cabinet, a contribution of £17,000 subject to match funding from

CBC.

In relation to the loan from CBC Huw advised that it had been on a loan basis and should, overtime, be repaid. He would however speak to the Leader of CBC.

Rachel Driver, Bill Furness and Karen Peck left the meeting at 1055 hours.

Wes enquired if any monitoring should take place. It was agreed that this be done on a six monthly basis. Huw suggested that it be on an SLA basis.

Agreed that Steve draft a letter to the Credit Union confirming the contributions agreed at the meeting, based on financial plan interest at 3%, and advising on the monitoring arrangements to be put in place.

Steve Lee left the meeting at 1110 hours.

3. Notes of the meeting held on 20th June 2013

Page 1 – Transformation Challenge Fund – Mark advised that the bid had been unsuccessful. He mentioned that High Peak and Staffordshire Moorlands had been awarded £200,000. There would however be another opportunity to bid in the future. He added that the review of Procurement would have been funded from this and enquired if the review would still be required. It was agreed to await the discussions with DCC on Shared Services. Mark agreed to progress informal discussions with DCC.

Wes spoke of some issues with the current arrangements with Procurement and advised that Bryan Mason was following this up with Bassetlaw.

Huw advised that the interim arrangement of 3 days per week at CBC was working well. They were looking at an internal Unit.

Page 1 – Crematorium – Distribution of Surpluses – Huw advised that the appeal hearing had found in favour of the applicant. He said that CBC would therefore be requesting that surpluses be returned to each authority in 13/14. Wes agreed to speak to the Leader/Deputy Leader at BDC to gain their views on future years.

Page 1 – Economic Development Priorities North Derbyshire District and Bassetlaw District Council – wait and see if any comeback.

Page 2 – *Audit* – Head of Internal Audit Consortium position not yet advertised. Derbyshire Dales are interested in joining the Consortium. Discussions to take place at Derbyshire level.

AGREED that the Notes of the meeting held on 20th June 2013 be approved as a true and correct record.

FOR PUBLICATION

1.0 PURPOSE OF REPORT

- 1.1 To consider and approve a draft of the next edition of the 'Working Together' newsletter.
- 1.2 To provide an update on changes to the councils' communications teams.
- 1.3 To consider whether further editions of the Working Together newsletter should be produced.

2.0 BACKGROUND

- 2.1 Communications support is rotated around the partners annually. CBC took on the role from September 2013.
- 2.2 Activity is focusing on external communication (mainly news releases) and internal communication (the 'Working Together' newsletter, distributed to staff and members of the three authorities).

2.3 LATEST PROMOTIONAL ACTIVITY

- 2.4 Recent promotional activity has included the following press releases:
 - Small businesses urged to apply for government funding (see appendix 1)
 - Chesterfield and North East Derbyshire Sports awards joint release between NEDDC and CBC (see appendix 2).
- 2.5 The next edition of the Working Together newsletter will be distributed during November 2013. A draft of the newsletter is at Appendix 3, and comments / approval is sought from the Joint Board.

3 COMMUNICATION STAFFING CHANGES

- 3.1 CBC: No changes.
- 3.2 NEDDC and BDC: Following the departure of the NEDDC communications officer in October 2013 communications staff across both councils are to work together in an interim structure.
- 3.3 The communications officer at BDC has been seconded to work with colleagues at NEDDC for two days a week and will manage the communications team, excluding design and print. He will do this in addition to his existing duties at BDC.
- 3.4 The NEDDC internal communications officer will work 22.5 hours a week instead of 18.5 hours to help cover some of the external communication work.
- 3.5 The move is part of joint working arrangements between the two councils.
- 3.6 Updated contact details can be found at Appendix 4.

4 FUTURE OF WORKING TOGETHER NEWSLETTER

- 4.1 The Working Together newsletter was set up to inform staff and members in the three councils about joint working taking place.
- 4.2 However, for some time the task of producing the newsletter has become very difficult and time consuming because of a lack of information to put in it.
- 4.3 This is also resulting in the use of stories that do not really merit being in a newsletter and communications officers spending considerable amounts of time trying to find stories to fill the gaps on the pages.
- 4.4 Following the changes to communications staffing levels highlighted above this task is going to get harder still in the future.
- 4.5 At the same time the relationship of joint working has changed over time. For example, CBC no longer does its procurement through joint working arrangements.
- 4.6 BDC and NEDDC are now in a strategic alliance which means they are doing more joint working than ever before. However, staff are reluctant to put stories about this in the Working Together newsletter because it wouldn't be relevant to CBC staff or members.
- 4.7 As a result it is recommended that the Joint Board considers whether the newsletter should continue to be produced.
- 4.8 Staff could instead be kept informed on joint working initiatives through individual council staff newsletters and intranets. This would make any stories relevant to the audience and improve efficiency.
- 4.9 It is proposed that the three council communication teams will continue to work together on promotional campaigns and press releases as these would continue to provide opportunities for joint working and efficiencies.

5 **RECOMMENDATIONS**

- 5.1 The Joint Board considers and approves the draft 'Working Together' newsletter at Appendix 3.
- The Joint Board considers ending production of the Working Together newsletter with staff instead informed of joint working through individual council staff newsletters and intranets.
- 5.3 The Joint Board notes the staffing changes and updated contact details at Appendix 4.

News Release

Small businesses urged to apply for government funding

Wednesday 25 September 2013

Business leaders in North Derbyshire are being urged not to miss the deadline to apply to a new round of funding designed to help small businesses grow.

Council leaders in Bolsover, Chesterfield and North East Derbyshire are reminding businesses that they have until the end of October to express an interest in the Regional Growth Fund (RGF) money, which is being made available through the Sheffield City Region Local Enterprise Partnership (LEP).

It signals a new phase in the LEP's 'Unlocking Business Investment' business programme – with it now earmarking £2.5m of its RGF fund for smaller grants starting from £25,000. A further £7.5m is being made available for grants of over £100,000.

Applications should be made to the Sheffield City Region Local Enterprise Partnership – of which the three authorities are members – and must come from businesses which can demonstrate 'robust plans for growth.'

Bolsover District Council Leader, Cllr Eion Watts, said: "Millions of pounds of funding continue to be made available to businesses across the Sheffield City Region – now including smaller grants for smaller firms. This represents a huge investment into the local economy and we urge businesses from North Derbyshire to apply for their share."

Cllr John Burrows, Chesterfield Borough Council Leader, added: "We have many thriving businesses in our area and this is a fantastic opportunity for them to continue to achieve their growth plans, despite the difficult financial climate, while contributing to job creation."

Projects will be assessed on a competitive basis – and the criteria for assessment will be:

- The number of new sustainable, private sector jobs created
- The level of private sector investment
- 'Additionality' potential for business growth and not displacement
- Eligibility for RGF support including issues such as State Aid compliance
- Deliverability and ability to have an immediate impact

- Value for public money

Cllr Graham Baxter MBE, North East Derbyshire Leader, added: "We would urge firms to get in touch with their local Economic Development Team to discuss the opportunity and find out more about how they could be eligible for funding."



Chesterfield and District Crematorium has received a prestigious Green Flag Award. The crematorium is run by the Joint Chesterfield and District Crematorium partnership on behalf of Chesterfield BC, Bolsover DC and North East Derbyshire DC.

The Green Flag is awarded by the environmental charity Keen Britain Tidy and recognises the best parks and green spaces in the country.

It is the sign to visitors that the space boasts the highest possible standards, is beautifully maintained, and has excellent facilities.

This year saw a Never Land Memorial Garden opened in the grounds of the crematorium in conjunction with the still birth and neonatal death charity, Chesterfield SANDS.

The garden features a Peter Pan memorial for parents who have lost a little boy, a Tinkerbell memorial for parents who have lost a little girl and a Lost Ones memorial for parents who have lost

babies before knowing the sex of the child.

As many parents who have lost a child have other children, there is also a Wendy house for the children to play while the parents visit the memorials.

Crematorium staff and Chesterfield SANDS have also taken part in filming with Big Buddha Films for the documentary Still Born, Still Loved.

An emotional service saw the candles in the baby garden in the crematorium grounds.

The candles will be left to burn for an hour in memory of all babies who have died.

New way forward for procurement

Departures from the three councils' shared procurement unit (SPU) will lead to changes in procurement from this autumn.

Bolsover DC, Chesterfield BC and North East Derbyshire DC entered into the SPU in 2007 hosted by Bolsover DC. Ashfield DC and Mansfield DC joined the consortium in 2011.

The SPU was originally set up to offer the following benefits:

- Reduced operating costs
- Opportunities to aggregate spending and maximise savings
- Standardising documentation
- Sharing best practice.

Over the last six years, the SPU has reduced operating costs for member councils and significant savings have been made, while some aggregation of spending has been achieved, this has been slower than hoped.

By July 2013, all three procurement officers have left the shared procurement unit for new challenges elsewhere, leaving the future of procurement at a crossroads.

The partners have been approached by Bassetlaw DC, who has offered to provide a shared procurement service for all five councils within the existing costs.

Chesterfield BC's cabinet discussed the issue at their meeting in July and decided that, with several high profile projects coming up, such as building the new Queen's Park Sports Centre, the best way forward for the authority was to employ a new in-house procurement team.

Chesterfield's cabinet members were keen, though, to maintain informal links with the SPI to maximise opportunities from aggregating spending and strategic business transformation savings.



Sheffield City Region consultation



This summer saw the Government launch a public consultation on plans for a combined authority for the Sheffield City Region (SCR).

All three authorities are members of the local enterprise partnership, which also includes Barnsley, Bassetlaw, Derbyshire Dales, Doncaster, Rotherham and Sheffield.

The consultation askes for public views on the document which would create a combined authority to cover all nine local authority areas.

Each of the local authorities submitted a proposal to the Government earlier this year to say they wanted to work more closely together to boost economic growth and create jobs.

This new authority, to be known as the Sheffield City Region Authority, would have responsibility for transport, economic development and regeneration and would also replace the South Yorkshire Integrated Transport Authority.

Each of these authorities have a long history of working together and setting up the SCR Authority will put into legislation a partnership which has been in place for some time.

Councillor Sir Stephen Houghton CBE, Leader of Barnsley Council and Chair of the 'shadow' SCR Authority said: "We welcome the Government's intention to formally recognise the Sheffield City Region Authority.

"This arrangement comes at no extra cost to tax payers and involves no powers being given up by individual local authorities. This is about having robust, democratically accountable structures in place at a City Region level. These structures mirror and complement the private sector-led LEP of which each local authority Leader is an active member.

"This step puts the Sheffield City Region ahead of the game compared with other areas of England. We will be ideally placed to secure devolved powers and funding which Government seek to hand down.

"Leaders from the Sheffield City Region will be considering the detail of the Government's document and put forward a response as a shadow combined authority."

The consultation closed on Monday 7 October.

The results will be published in the autumn.

Local transport major projects announced

This summer saw the Local Transport Body (LTB) publish a list of major projects which will have the biggest impact on jobs and economic growth in the Sheffield City Region in the next 10 years.

Seventeen projects have been ranked according to the benefit it is likely to have on economic growth and jobs in the area.

These projects include Chesterfield Northern Gateway and Chesterfield Waterside developments.

Two further projects, including Markham Vale – Seymour Link Road have also been identified as needing further testing before their gross value added (GVA) score can be decided.

Analysis shows that if the LTB were able to invest in all 19 schemes across the Sheffield City Region, then the combined projects could boost the local economy between £5 and 7 billion.

Sheffield City Region made an agreement with the Government in 2012, through the 'City Deal' programme – meaning that it is one of only four places in the UK to secure a 10 year allocation of funding of transport and infrastructure projects.

The LTB will be analysing the projects on the list to make sure the impact of investment decisions

are spread across the Sheffield City Region, which covers Barnsley, Bassetlaw, Bolsover, Chesterfield, Derbyshire Dales, Doncaster, North East Derbyshire, Rotherham and Sheffield.

LTB Chair, Councillor Sir Stephen Houghton CBE, said:

"Through this process, the LTB has compared the largest transport and infrastructure projects across the City Region and ranked their impact on economic growth and jobs.

"This analysis shows the huge scale of opportunity to boost economic growth in the Sheffield City Region. Investing in these 19 schemes has the potential to increase the City Region's economic output by over 20 per cent and create almost 4,500 sustainable new jobs.

"This massive return on investment reveals the incredible untapped potential in the Sheffield City Region."

Residents have their say through housing survey

Thousands of residents across Chesterfield and Bolsover have been asked for their help to identify future housing needs.

Working with GL Hearn, Chesterfield Borough Council and Bolsover District Council have sent out a housing needs survey to a sample of 20,000 households across the area. The survey was designed to capture a current picture of local housing and needs of its residents.

The results will provide an insight into the kinds of housing local people want and need, and will be used to help shape the two council's services over the coming years.

The two councils also held a consultation event for developer's and housing associations' at Dunston Innovation Centre in July. More than 50 representatives attended the consultation.

Results of the survey will be revealed in autumn.



From protestors who changed the national landscape to wartime tragedies and icons of the industrial age, the hidden sights and sounds of North Derbyshire are brought to the life in a series of free audio trails.

The series of 16 'Hidden Gem' trails – which features walks from Bolsover, Chesterfield and North East Derbyshire - is now complete, and all are free and available to download from the website at www.ne-derbyshire.gov.uk/hidden-gems

A handy guide to the walks has also been produced, helping people to plan their discovery of the district – available from community venues and also on the website.

Bringing to life the history and heritage of the district through narration by, and interviews with, local people, the trails have been put together with the help of a variety community organisations, groups and parish councils.
