

**1.0 PURPOSE OF REPORT**

1.1 To seek Executive Member approval for an agreement with Derbyshire County Council to construct a shared use cycleway/footway on a grass verge within CBC ownership shown by a thick black line on the attached plan.

**2.0 RECOMMENDATIONS**

2.1 It is recommended Executive Member approves the agreement with Derbyshire County Council to construct the shared use cycleway/footway on CBC land.

**3.0 BACKGROUND AND PROPOSAL**

3.1 It is proposed that the shared use cycleway/footway will be constructed on CBC land on the eastern side of Loundsley Green Road and will run in a southerly direction, on the wide grass verge, from the junction with Newbold Road for approximately 250 metres. The location is shown on the attached plan.

- 3.2 At the northern end it will tie into an existing footway and here the new path will be signed to say that the cyclepath ends. In the longer term, it is proposed that the existing pedestrian crossing on Newbold Road (east side) be changed to a Toucan crossing and the cycle route be continued along Newbold Road. At the southern end, it will tie into an existing shared use path. The proposed route will complete one of the links shown on the Chesterfield Cycle Network which was prepared jointly with CBC/DCC in 2011, and fits with the objectives of the Local Plan.
- 3.3 Derbyshire County Council will be responsible for carrying out the works and all future maintenance of the shared use path. CBC will draw up the agreement with DCC liable for CBC's fees.

10.1 The new pathway will complete one of the links shown on the Chesterfield Cycle Network and fits with the objectives of the Local Plan.

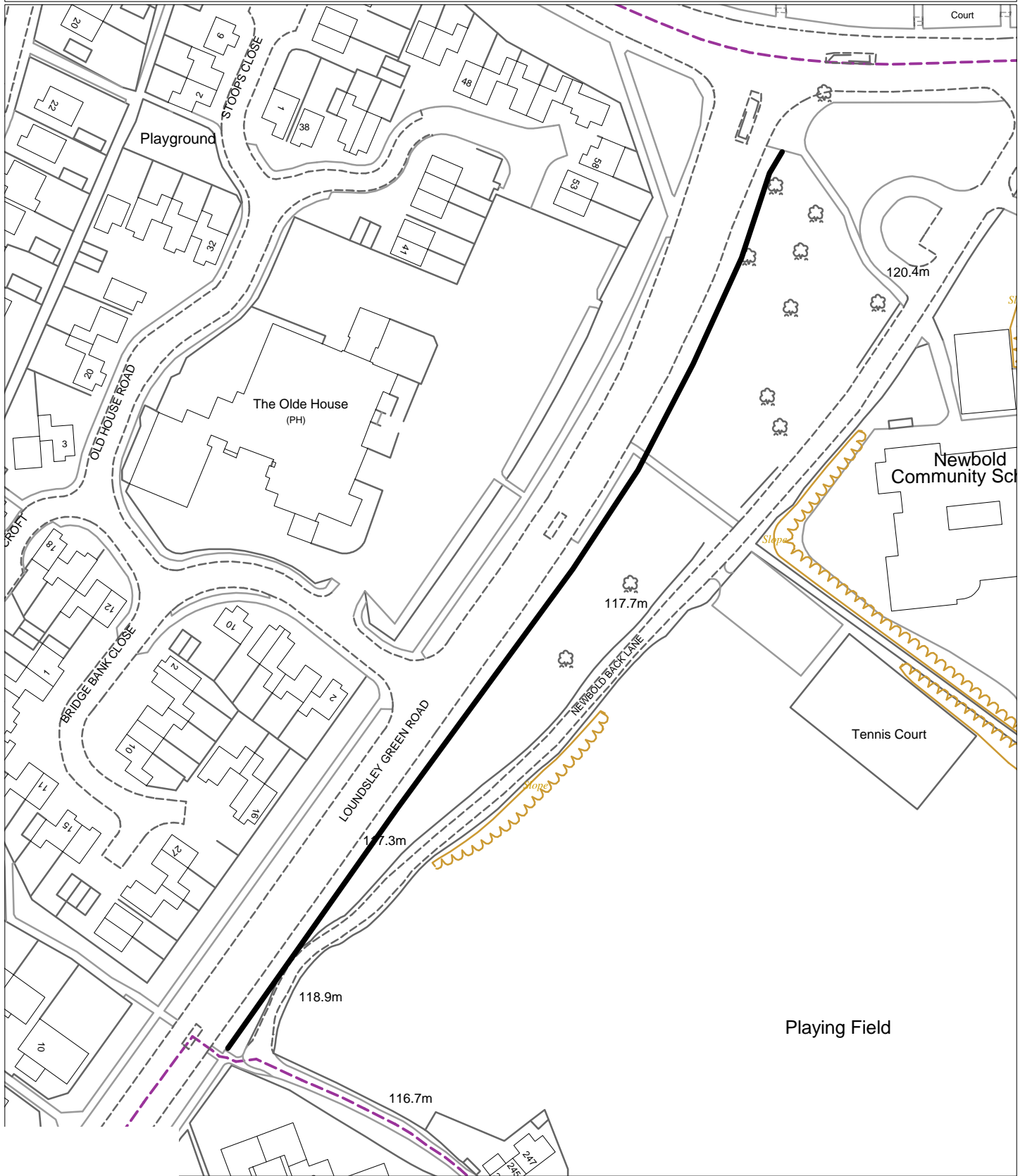
