ENTERPRISE AND WELLBEING SCRUTINY COMMITTEE SPECIAL MEETING OF 20 OCTOBER 2014

Findings of the Scrutiny Project Group looking at the Proposed Playing Pitch Strategy :

The Enterprise and Wellbeing Scrutiny Committee held 2 October 2014 considered the draft Playing Pitch Strategy and associated draft cabinet report recommendations.

The Committee resolved to support the draft strategy and draft cabinet report recommendations subject to any further findings of a Scrutiny Project Group.

The Scrutiny Project Group has subsequently reviewed the draft strategy further, and makes the following recommendations to the Committee :

1. That the Enterprise and Wellbeing Scrutiny Committee reaffirms its support for the draft Playing Pitch Strategy and draft cabinet report recommendations, as considered and agreed on 2 October 2014.
2. That a progress report is brought to the Enterprise and Wellbeing Committee in 12 months time to :
 - a) confirm the status of the strategy implementation and delivery; and
 - b) confirm whether the strategy has started to reverse the shortfall of junior teams and interest in playing by young people, both boys and girls.
