1.0 **Purpose of report**

1.1 For Members to determine the application made by Layals Limited for a new premises licence in respect of

The Cricketers Inn Convenience Store,
Stand Road,
Newbold,
Chesterfield,
S41 8SJ.

1.2 A relevant representation have been made in respect of the application and not withdrawn. Consequently the application

cannot be granted or refused under officer delegated authority.

2.0 **Recommendation.**

That the Committee hear details of this license application and determine whether it is

- Granted
- granted with conditions
- or refused.

2.1 A copy of the Application Form is attached to this report at Appendix 1. Appendices 2, 3 and 4, show the proposed licensed area, the site plan and a front elevation drawing of the premises.

3.0 **Report Details.**

3.1 The premise is an existing public house, for which a current premises licence is granted. A copy of the current premises licence is attached at Appendix 5.

3.2 Layals Limited became the premises licence holder for the premises on 19.07.17.
Having acquired the premises licence and control of the property, Layals Limited initially continued to trade the premises as a public house and subsequently sought planning permission to change the use of the premises to an off licence.

3.3 A conditional planning permission was granted in January 2018 which authorised only part of the premises to be changed to an off licence whilst the remainder was to continue in it's current use as a public house licensed premises. Appendix 2 shows this split, with the red outlined

area being changed to the off licence and the remaining part of the building continuing as the public house.

- 3.4 Building and shop fitting works are currently under way to construct the segregation between the two separate trading areas in the premises and make the off licence ready for use.
- 3.5 The Cricketers Inn stands in the middle of a residential development, adjacent to the Local Authority Park on Stand Road. The photograph below shows the premises location in relation to the Park.



- 3.6 The next photograph shows the front of the premises, the car parking around it and its proximity to the park entrance which can be seen across the road.



4.0 **Application**

4.1 The application received in Licensing on 14th March 2018 is for a new Premises Licence.

4.2 The applicant's intention is to use the new licence for the off licence part of the premises (if granted) and then vary the original licence to operate the remaining public house area.

4.3 The rationale behind applying in this fashion was to keep the two premises licensed separately. This took into account that simply amending the current licence would require a variation to the premises licence to accommodate the additional alcohol sales hours sought on Sundays.

4.4 The application does not seek any licensable activity other than the sale and supply of alcohol, off the premises.

- The hours applied for are 07.00 am to 11.00 pm from Monday to Sunday.
- There are no proposed non-standard timings.
- Opening hours of the premises are also identified as 07.00 am to 11.00 pm from Monday to Sunday.

- 4.5 Applications for a new Premises Licence are required to be advertised by way of an advert in the local press, a site notice displayed at the premises and copies of the application submitted to all Responsible Authorities.
- 4.6 A copy of the appropriate local press advert taken from the Derbyshire Times on Thursday 15th February 2018 is attached at Appendix 6.
- 4.7 The site notices displayed on the premises, advertising the application were viewed by licensing enforcement staff on 14th February 2018 and found to be displayed correctly and completed appropriately.
- 4.8 The application was submitted on line and as such, the Chesterfield Borough Council Licensing Authority circulated a copy of the application to the responsible Authorities.
- 4.9 The statutory deadline for representations was 8th March 2018.
- 4.10 Responsible Authorities and Interested Parties are entitled to make representations to the Licensing Authority provided they are relevant.
- 4.11 A representation was received on 6th March 2018 and accepted. The representation was received from the chairperson of "Friends of Stand Road Park" a local community group. The letter makes representation in relation to one or more of the licensing objectives which are:-
- the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - protection of children from harm

A redacted copy of the letter of representation is shown at Appendix 6.

5.0 **Representation**

5.1 The representation that has been submitted in respect of this application engages three of the four licensing objectives, namely

- the prevention of crime and disorder
- the prevention of public nuisance
- protection of children from harm

and expresses concerns over alcohol fuelled antisocial behaviour and criminal damage to the park.

5.2 The letter of representation describes the Friends of Stand Road Park as a community group made up of park users and other members of the community who have an interest in Stand Road Park. Their stated mission is to see the park transformed into a community park that is safe and enjoyable for everyone and something the community will be proud of.

5.3 Reference is made in the representations to improvements fostered in the park, diversionary activities provided for teenage children to deter antisocial behaviour and the provision of a café facility at the weekends.

5.4 The nature of the objection focuses on the fact that the Cricketers Inn is located not only in close proximity to the park but also very close to the youth diversionary activity sites on the park. There is a concern that the additional availability of alcohol from an off licence so close to the park will inevitably increase the likelihood of incidents involving alcohol fuelled antisocial behaviour and criminal damage to the park.

5.5 The representation recognises that any premises licence granted would include control measures around the sale of age-restricted goods but this would not address the issue of proxy sales.

- 5.6 As part of the application process the applicant is required to describe in the operating schedule the additional steps that are intended to be taken in order to promote the licensing objectives for the new premises licence that has been requested.
- 5.7 Under the Licensing Act 2003, these volunteered proposed steps will be attached to the premises licence as conditions which must be complied with. These are set out in Part M of the application form at Appendix 1. The Trading Standards approved age related control measures are included therein.
- 5.8 The representation also states

“Although the level of anti-social behaviour and criminal damage at the park has reduced over the last ten years, thanks to the efforts of the local Police Safer Neighbourhoods Team working in partnership with Friends of Stand Road Park, it has not been eliminated altogether.

Incidents of violent behaviour and criminal damage, which our intelligence indicates to have been fuelled by the consumption of alcohol, have occurred in the recent past. Examples include the following, all of which were reported to the Police:

- On the Friday evenings of 1st and 8th September 2017 there were incidents involving violent altercations on the park involving verbal abuse and fighting.*
- On 8th September criminal damage to recently planted tree saplings, which we believe is linked to the foregoing altercations, occurred and was subsequently reported to the police.*
- On a date in January 2018 a woman walking on the park with a young child in a buggy was assaulted by a drunken man. Another woman who came to assist was beaten on her arm with a bottle. The incident was reported to the police.”*

5.9 To better help to qualify the incidents mentioned, information has been sought from Chesterfield Borough Council's Community Safety Department, Pollution Control Department and from Derbyshire Police. A summary of their responses can be seen below.

Chesterfield Borough Council Community safety

"Alcohol is not currently an issue on Stand Road Park. In the past there has been some minor anti-social behaviour issues on the park such as the damage to the tree saplings however we have no knowledge of this incident being fuelled by alcohol. As for the other two incidents highlighted I have no knowledge of them so could not comment whether they were alcohol related or not. At the minute we are not seeing any significant anti-social behaviour issues or criminal activity in the park.

We often get complaints regarding behaviours of young people in parks across the borough stating that the young people are drinking alcohol or are drunk but more often than not this is not the case and it's just youths congregating in the parks with their mates and sometimes acting immaturely."

Chesterfield Borough Council Pollution Control

"I have spoken with the street cleansing team and last year they received many calls for service for alcohol related litter in Stand Road park (e.g. cans, bottles etc...).

We have had complaints about noise from the pub in

- December 2015*
- May, June, August 2016*
- July, September 2017.*

but they never reached formal investigation stage. "

Derbyshire Police Licensing Department

"I have trawled all records of contact with the police over the last three months and also as a "one-off" for the whole of September 2017 for anything which can be associated with STAND ROAD.

In summary:-

- 30/01/18 – report of ASB which in reality concerned aspects of school bullying – no offences*
- 09/01/18 – actually linked to the above incident – ongoing bullying*
- 30/12/17 – report of ASB and "kids" smashing up something on skate park – no offences*

September:-

- 21/09/17 – suspicious incident reported involving staff members from circus – no offences*
- 11/09/17 – damage to saplings – crime recorded*
- 02/09/17 – kids taking drugs – no offences*

In light of this I cannot see any direct implications to off-licence sales and therefore cannot see any reason for the police to object to introduction of off-licence at the CRICKETERS."

6.0 **Conclusion**

- 6.1 When carrying out its licensing functions, the Licensing Authority must do so with a view to promoting the 4 licensing objectives and also with regard to its Statement of Licensing Policy and the guidance issued by the Secretary of State under section 182 of the Licensing Act 2003.
- 6.2 Where either the applicant or a person who made relevant representations is aggrieved by the decision of the Licensing Authority, appeal is to the Magistrates' Court.

- 6.3 As relevant representations have been made in respect of the application and not withdrawn, the application cannot be granted or refused under officer delegated authority.
- 6.4 The Licensing Committee is therefore asked to determine the application by
- granting it as requested
 - granting it subject to conditions
 - or refusing the application.







Retailing of Alcohol

1. No supply of alcohol may be made under the premises licence -

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The Licensing Act 2003 (Mandatory Conditions) Order 2014 Conditions in force from 28th May 2014

(1). A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(2). In this condition:-

a. "permitted price" is the price found by applying the formula $P = D + (D \times V)$, where-

- i. P is the permitted price,
- ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- b. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
 - i. the holder of the premises licence,
 - ii. the designated premises supervisor (if any) in respect of such a licence, or
 - iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- e. "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

(3). Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.

(4). Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Mandatory Licensing Conditions**

1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or
 - (b) an ultraviolet feature.
4. The responsible person must ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

B. EMBEDDED RESTRICTIONS UNDER THE CHILDREN AND YOUNG PERSONS ACT 1933

The Premises Licence is subject to the restrictions contained in the Children and Young Persons Act 1933 to the extent that any of those restrictions were imposed on the use of the premises for the existing licensable activities under the relevant existing licence or licences.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

An application to vary the Premises Licence was submitted to the Council on 28th June 2007 to make structural alterations to the original plan and to extend the hours for all existing licensable activities. The applicant did not state any additional steps in promoting the four licensing objectives as a result of the proposed variation.

The following text is from the Operating Schedule

General - All Four Licensing Objectives

Following the assessment of the premises and its surrounding area the following is proposed. 30 minute "drinking up" time will allow appropriate dispersal, use of lavatories etc. In order to further the licensing objectives the licensee reserves the right to move the fire appliances, AWP machines, cigarette machines and any other similar objects temporarily in a fixed location which may impact on the ability of individuals on the premises to use exits or escape routes without impediment.

Prevention of Crime and Disorder

Illumination is provided to the exterior areas of the pub
All interior trading areas are clearly visible from the bar
There is always a minimum of two staff on duty during busy times
Toilets are checked regularly by all pub staff
Toilet access is clearly visible to staff
The licensee and staff monitor customer behaviour especially during busy times
Most customers are local
Drug prevention measures are used in the outlet

Public Safety

Health and Safety policy in place is adhered to
The pub is equipped with emergency lighting, illuminated exit signs and a fire detection system throughout the entire building
All firefighting equipment is serviced annually
There are current electric and gas certificates in place
Mechanical extraction system is provided in the bar
Pub complies with smoking charter
Maximum effort is placed on providing a smoke free environment with the use of extractors and smoke filters

The fact that this public house is a one engineering brick thick detached property assists in minimising noise transfer

Following the receipt of relevant representations the Licence holder agreed to the following modification/condition to the operating schedule:-

1. The Designated Premises Supervisor will consider the use of door supervision as part of the risk assessment carried out at times when regulated entertainment is provided.

Application by Layals Ltd for a license for off sales of alcohol from Cricketers Inn Convenience Store, Stand Road, Chesterfield.

I am instructed by the committee of Friends of Stand Road Park to write to you to object to the above license application.

Our interest in the matter

Friends of Stand Road Park are a community group made up of park users and other members of the community who have an interest in Stand Road Park.

Our mission is to see the park transformed into a community park that is ***safe and enjoyable for everyone and something the community will be proud of.***

Although our mission is not yet fully achieved we have made great progress since our group was first established. Over the last twelve years we have made improvements to the park to a value in excess of £250,000. The improvements include the provision of a multi use games area and skateboard park to allow teenage children to engage in constructive recreational activities and help steer them away from antisocial behaviour. We have also provided a small café in the park pavilion that is staffed by our volunteers on Saturdays during the football season, a play area for very young children and a designed wetland feature planted with wet-loving plant and tree species.

Our objections to the license application

The premises to which the application applies are on Stand Road and located immediately adjacent to the park. In particular, the premises are just a short distance from the skateboard park and multi use games area both of which are popular with teenage children.

Our committee believes that the granting of a license for the off sale of alcohol from premises located so close to the park and, in particular, so close to that part of the park that is popular with teenage children, will inevitably increase the likelihood of incidents involving alcohol fuelled antisocial behaviour and criminal damage to the park.

We believe that granting a license would work against the “prevention of crime and disorder” and “prevention of public nuisance” licensing objectives as well as the objective aimed at “protection of children from harm”. Although any licensing conditions would include the standard conditions aimed at preventing the sale of alcohol directly to children and young people, there have been plenty of examples of young people getting hold of alcohol purchased on their behalf by young adults and we believe that there will be a real risk of this happening at Stand Road if the license is granted.

Although the level of anti-social behaviour and criminal damage at the park has reduced over the last ten years, thanks to the efforts of the local Police Safer Neighbourhoods Team working in partnership with Friends of Stand Road Park, it has not been eliminated altogether.

Incidents of violent behaviour and criminal damage, which our intelligence indicates to have been fuelled by the consumption of alcohol, have occurred in the recent past. Examples include the following, all of which were reported to the Police:

- On the Friday evenings of 1st and 8th September 2017 there were incidents involving violent altercations on the park involving verbal abuse and fighting.
- On 8th September criminal damage to recently planted tree saplings, which we believe is linked to the foregoing altercations, occurred and was subsequently reported to the police.
- On a date in January 2018 a woman walking on the park with a young child in a buggy was assaulted by a drunken man. Another woman who came to assist was beaten on her arm with a bottle. The incident was reported to the police.

We believe that the granting of a license will increase the risk, and therefore the frequency, of incidents of these sorts of alcohol fuelled, anti-social and criminal behaviour at Stand Road Park and this will act to undo the great progress that has been made over the last few years in making our park **safe and enjoyable for everyone**.

Alcohol is not currently an issue on Stand Road Park. In the past there has been some minor anti-social behaviour issues on the park such as the damage to the tree saplings however we have no knowledge of this incident being fuelled by alcohol. As for the other two incidents highlighted I have no knowledge of them so could not comment whether they were alcohol related or not. At the minute we are not seeing any significant anti-social behaviour issues or criminal activity in the park. We often get complaints regarding behaviours of young people in parks across the borough stating that the young people are drinking alcohol or are drunk but more often than not this is not the case and it's just youths congregating in the parks with their mates and sometimes acting immaturely.

They cite the following events which they have intelligence to indicate were fuelled by alcohol consumption.

- 010917 and 080917 – violent altercations on the park with verbal abuse and fighting
- 080917 – damage to recently planted tree saplings, apparently linked to the altercations mentioned previously
- January 2018 – female with a young child in a buggy assaulted by a drunken man who also assaulted another woman who came to assist.

The reason I write is to ask whether you can provide any additional information around crime/ASB / Noise pollution.

I know noise pollution was a constant theme in the area last year and I would be grateful of any info or stats that can be supplied.

Similarly I would like to know if there is any additional information to better describe the other events mentioned – within the bounds of data protection of course.

The representor is to a certain degree trading on the fear of the unknown, believing that the opening of an off-licence, with the subsequent risk of under-age and proxy sales being mentioned, will make matters worse in the area.

As it stands at the moment, the complaints all pre-date the presence of the yet-to-open store and with the abundance of nearby pubs and supermarkets I suspect it will be difficult to place any blame with the applicant.

Basically any information (statistical or otherwise) that would better inform the representation, either by supporting or refuting it would be gratefully received.

Dear police and pollution

The new premises application for an off licence at The Cricketers Inn site on Stand Road has almost run it's course.

The final day for representations ifs 09.03.18.

We have just received a representation from the "Friends of Stand Road Park" association who identify all the good work they have done to improve the facilities and usage of the park.

Their letter refers to the young demographic of park users and expresses concern that a greater availability of alcohol would have a negative effect, impacting by increasing alcohol-fuelled antisocial behaviour, violence and criminal damage.

They cite the following events which they have intelligence to indicate were fuelled by alcohol consumption.

- 010917 and 080917 – violent altercations on the park with verbal abuse and fighting
- 080917 – damage to recently planted tree saplings, apparently linked to the altercations mentioned previously
- January 2018 – female with a young child in a buggy assaulted by a drunken man who also assaulted another woman who came to assist.

The reason I write is to ask whether you can provide any additional information around crime/ASB / Noise pollution.

I know noise pollution was a constant theme in the area last year and I would be grateful of any info or stats that can be supplied.

Similarly I would like to know if there is any additional information to better describe the other events mentioned – within the bounds of data protection of course.

The representor is to a certain degree trading on the fear of the unknown, believing that the opening of an off-licence, with the subsequent risk of under-age and proxy sales being mentioned, will make matters worse in the area.

As it stands at the moment, the complaints all pre-date the presence of the yet-to-open store and with the abundance of nearby pubs and supermarkets I suspect it will be difficult to place any blame with the applicant.

Basically any information (statistical or otherwise) that would better inform the representation, either by supporting or refuting it would be gratefully received.
