## Percent for Art Scheme at Dunston Road

#### 1.0 **Purpose of Report**

1.1 To consider a short list of artists for a permanent percent for art scheme for Land to the west of Dunston Lane, Dunston.

#### 2.0 Background

- 2.1 A requirement to provide a public work of art was included in the S106 unilateral undertaking associated with planning applications (reference CHE/14/00873/OUT, CHE/16/00016/OUT and CHE/17/00381/REM) for residential development at Land to the west of Dunston Lane, Chesterfield.
- 2.2 A sum of £100,000 was agreed for the project.
- 2.3 William Davis contacted a number of artists with a short brief setting out the site details, potential

location of the artwork and budget and asked the artists to put forward designs ideas.

- 2.4 Following the submissions a short list of three artists were selected by the developer's representative, council officers and Councillor Terry Gilby at a meeting on the on 12<sup>th</sup> June 2019.
- 2.5 The following artists selected to present their schemes to the meeting are;
  - Hilary Cartmel & Michael Johnson
  - Denis O'Connor
  - Richard Thornton

# 3.0 **Considerations**

- 3.1 The concepts for each of the designs are available to view at (link to be provided)
- 3.2 A 15 minute time slot is allocated for each of the artists to present their designs. Consideration should be given to the following;
  - An introduction to their work outlining previous experience and relevant commissions,
  - Reference to any research in contributing to their submitted proposal and its relevance to the site/area, including any community engagement
  - reference to health and safety considerations i.e. demonstrate that the proposal is safe, robust, durable and requires minimum maintenance.
  - sustainability attributes of any materials used
  - size, scale and accessibility
  - budget considerations and timescales

- Installation requirements
- 3.3 The artist(s) will take questions from the developer and the sub-committee.
- 3.4 Following the presentations there will be an opportunity to discuss the proposals to agree a preferred option.

#### 4.0 **<u>Recommendation</u>**

4.1 That members jointly with the developer select an artist for the commission.
