If the nominated member of staff observes behaviour which may cause a nuisance to local residents or a breach of the licence conditions they will take appropriate action to remedy this. Any incident observed and the outcome will be documented and made available to an authorised officer upon request. 2. Whenever amplified regulated entertainment is hosted at the premises, the management will conduct regular assessment of the noise emanating from the premises. Where such assessments indicate that the level of noise may cause nuisance to local residents, the management will take action to remedy the level of noise. Said
