39 MAYOR'S COMMUNICATIONS

- The launch of the "Be a Star" campaign showcasing small independent businesses in Chesterfield and encouraging people to shop local.

The Mayor thanked Members for wearing festive attire to the Council meeting to raise funds for the Mayor's Appeal.

40 APOLOGIES FOR ABSENCE

41 DECLARATIONS OF MEMBERS' AND OFFICERS' INTERESTS RELATING TO ITEMS ON THE AGENDA.

No declarations of interest were received.

42 PUBLIC QUESTIONS TO THE COUNCIL

Under Standing Order No. 12, the following question was asked by Martin Coslett:

"At the last meeting of Full Council a petition of 2400 signatures was submitted and a debate was held both urging the Council to pause, think again and plot a new and more positive future for Tapton House working with the Friends of Tapton House. Can I ask the Leader of the Council what lessons she drew from the debate and from the 2400 residents signatures and has she considered alternative plans for Tapton House in the light of that debate and petition?"

Councillor P Gilby provided a verbal response as follows:

- The decision had been delayed to take account of the outcome of the petition debate and the final decision made at the Cabinet meeting on 13 December, 2022.
- The petition debate had provided an opportunity for direct engagement with members, clarification that the Council and the Friends of Tapton House were equally committed to achieving the best outcome for Tapton House, several misconceptions to be dispelled, and further consideration to be given to the boundary treatments.
- A range of proposals had been received for the future use of Tapton House, including converting Tapton House into office accommodation. The petition debate had helped inform the development of the criteria used to evaluate the bids.
- The council's Cabinet had resolved to approve Stone Castle Enterprises Ltd. proposal, which would see Tapton House restored and converted for residential accommodation, alongside a commitment to retain the parkland for public use and create visitor access to part of the Georgian mansion.
- Stone Castle Enterprises Ltd. had confirmed that no hard boundary would be required and open public access to the parkland would continue. They would also seek to create a public heritage area in the building to ensure its past use as the home of Charles Paxton Markham and George Stephenson was celebrated and the importance of Tapton House to the town's history commemorated. Stone Castle Enterprises Ltd. had also expressed a keenness to work closely with the council, the Friends of Tapton House and the wider community.

The following supplementary question was asked by Martin Coslett;

How much space would be dedicated to public heritage?

Councillor P Gilby provided a verbal response advising that this had not yet been determined but a request had already been made by the developer to meet with the Friends of Tapton House to discuss the plans.

52 QUESTIONS UNDER STANDING ORDER NO. 19

Under Standing Order No. 19 Councillor Fordham asked the following questions:

 Given the Councils financial commitment to Chesterfield Football Club (CFC) and our support for inclusive sport articulated through several well-being strategies - what dialogue did the council have with CFC before the start of the Qatar World Cup about concerns over women's rights, migrant worker labour and lgbt+ inclusion? And to ask what statements did the Council issue (perhaps jointly with CFC) on these matters in advance of the World Cup commencing on 20th November?

Councillor Blank provided a verbal response confirming that the Council shared the concerns that were expressed regarding FIFA's Decision to award the 2022 World Cup to Qatar. The values of the Qatari regime were at odds with those of Chesterfield Borough Council and Chesterfield Football Club.

No statement was issued by the Council and no conversation took place with Chesterfield Football Club prior to the tournament. The Council instead chose to focus on matters of equality and diversity within Chesterfield borough's communities, as this is where it would have the greatest impact.

• Given the government have different schemes for Ukrainians seeking asylum, accommodation and work, what concerns does the

Council have about Ukrainians here in Chesterfield and North Derbyshire being at risk of homelessness?

Councillor P Gilby provided a verbal response advising that the Council had a proud history of welcoming people to Chesterfield. Chesterfield Borough Council had worked with partners to support Ukrainians to settle in the UK and access public services. The Council had expressed its concerns over the short-term nature of the Government's Homes for Ukraine scheme. The Derbyshire Partnership, of which Chesterfield Borough Council was a member, acknowledged the concerning number of Ukrainians now presenting as homeless. Preventative measures had been put in place.

The Leader assured the meeting that Chesterfield Borough Council would continue to support Ukrainian refugees to avoid homelessness and enable them to fully integrate into Chesterfield's communities.

53 NOTICE OF MOTION UNDER STANDING ORDER NO. 21

It was moved by Councillor Serjeant and seconded by Councillor Jean Innes that:

Increased Funding for Local Government

In Chesterfield many in our communities face an uncertain future with rising inflation and fuel costs. The disastrous mini-Budget of Truss and Kwarteng utterly transformed our politics the decisions made have affected our residents life chances for the next five or even ten years.

There is a straight blue line between the Conservative Government's failed mini-budget and the multi-billion pound blackhole in the nation's finances. Local government needs to come together to defend our local services from this Government.

The Conservative Government has crashed the economy, they must not take it out on Chesterfield. We call on the Prime Minister to protect local services by committing to increasing the funding of Local Government.
