1.0 **PURPOSE OF REPORT**

- 1.1 To inform the Crime and Disorder Committee of the progress of the Community Safety Partnership towards the delivery of the action plan refresh (2016/17). (Attachment A).
- 1.2 To inform the members of current crime trends for the last 3 months via data from Safer Derbyshire Research and Information (SDRI) team. (Attachment B)

2.0 **BACKGROUND**

- 2.1 Members will recall that the Community Safety Officer last attended the Crime and Disorder Committee in July 2015 to present the progress of Community Safety work and the associated reductions of crime and disorder in the borough of Chesterfield. The latest quarterly crime data performance report (September 2015) and alcohol related hospital

admissions statistics (October 2015) were distributed to Members of the Committee in January, 2016.

2.2 Committee Members have often asked questions around the priority action areas and other areas of interest or concern. They have made comments in relation to performance data and strategic project direction and have been able to challenge the progress of the Partnership Plan.

2.3 The Partnership is now nearing the end of the delivery cycle of the current plan and it would like to keep Members informed of some key project work that has now been completed and other work that is in progress.

3.0 **CRIME AND DISORDER COMMITTEE**

3.1 It is intended that the Committee shall be introduced to the new Community Safety Partnership Sergeant, Dave Harrison. Dave will be available to take questions in relation to policing across the borough as well as upon the strategic progress of the Partnership Plan.

3.2 The Community Safety Officer has supplied papers for circulation before the meeting, allowing Members time to reflect and to consider the work of the Partnership. The papers are:
