We most strongly oppose the Licence Asked for by BRAMPTON ROVERS HOLDINGS LTD We ask you to REFUSE it with no compromise on the following grounds

1 Prevention of Crime and Disorder

They can do all they want NOW with out a licence to sell Alcohol Regardless of what they say it will be ABUSED and criminal damage will take place Cars will get damage and local property. Because of the very limited car parking the lane will get blocked resulting in cars getting damaged and fighting will ensue especially when fuelled by alcohol

2 Public Safety

Car parking there is very little room Now on a Sunday they park all over the place and block the lane and the residents living down the lane cant get through We put up with that for the sake of the young people playing football. For there Access to go in and out The lane is a public footpath used by school children many wheel chairs mobility scooters etc. with all this proposed additional traffic the lane it is not suitable An elderly gentleman was hit by a car going to the football

They treat the lane as they own it and no one else should be on it It is not suitable for all these extra hours 8am to midnight

The access is not suitable for any more additional traffic it is full of pot holes some over 8" deep

3 The Prevention Of Public Nuisance

Loud amplified and Recorded Music This is a quiet residential area NOISE

POLLUTION is a serious offence Occasionally at the moment they have a children's party and in our bungalow and in our homes we can hear thump thump the beat but by11pm they have all gone

Not being satisfied with that. They want to subject us to more from 8am till midnight We know some of the council members have a vested interest in this project what is the ALTERER motive behind it all? Its not to do with the football club It is working perfectly well as it is. THERE is another agenda and if this licence is granted we will get the full brunt of it. They cant even look after the football field properly they rarely cut the out field its a disgrace so you cannot trust any thing they say. Drinking from 10am to midnight leaving up to 1pm in the morning car doors slamming. customers shouting. Screaming taxies piping there horns it is going to be unbearable You the licensing authority would not want it in your back yard so why should we. This is just the thin edge of the wedge please do not allow it.

And what about the wild life We have Bats they are very susceptible to noise it will ruin there habitat they fly at dusk and in the dark — There will be litter all over the place They will not be able to control where the alcohol is drunk IMPOSSIBLE. A quiet residential area is 30 Decibels Amplified music is 100 to 120 Decibels This is unacceptable.

4 The Protection of Children from Harm

The majority of children are between 6 & 10 well supported by parents watching Usually on a Saturday & Sunday. Why should these vulnerable young people be subjected to alcohol when they should be in a safe environment They have normally all gone home by 3 pm then we can sit in our gardens and enjoy the ambiance If you grant this we will all be prisoners in our own homes.
