#### **MANDATORY CONDITIONS**

1

No supply of alcohol may be made under the premises licence -

- () at any time when there is no designated premises supervisor in respect of the premises licence, or
- () at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2 Every supply of alcohol under the premises licence must be made or authorised

by a person who holds a personal licence.

#### **EMBEDDED RESTRICTIONS**

#### A. EMBEDDED RESTRICTIONS UNDER THE LICENSING ACT 1964

#### 1 PERMITTED HOURS

Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- a. On weekdays, other than Christmas Day, 8 a.m. to 11 p.m.
- b. On Sundays, other than Christmas Day, 10 a.m. to 10.30 p.m.
- c. On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m.
- d. On Good Friday, 8 a.m. to 10.30 p.m.

The above restrictions do not prohibit:

- (a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (c) the sale of alcohol to a trader or club for the purposes of the trade or club;
- (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

#### **2 CONSUMPTION**

Alcohol shall not be sold in an open container or be sold for consumption in the licensed premises.

## B. EMBEDDED RESTRICTIONS UNDER THE CHILDREN AND YOUNG PERSONS ACT 1933

The Premises Licence is subject to the restrictions contained in the Children and Young Persons Act 1933 to the extent that any of those restrictions were imposed on the use of the premises for the existing licensable activities under the relevant existing licence or licences.
