- **ANNEX 1 - MANDATORY CONDITIONS**

Retailing of Alcohol

These Conditions will be in force from 1st October 2010

1. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

2. The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied

having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

- (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

- **ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE**

An application to vary the Premises Licence was submitted to the Council on 9th March 2011 to change the store layout due to structural alteration, and to relocate the counter.

The following text is from the Operating Schedule:-

General

In respect of shop fitting and merchandising, the premises will be completed to the highest standards demanded by the premises licence holder. This ensures that the premises are suitable for the purpose of a retail specialist off licence in relation to appearance, layout and security.

The store staff are trained in three ways:-

1. The company run BII NCPLH courses on average, once a month. These courses are well attended, and it is strongly recommended that stores should have a number of Personal Licence holders in addition to the DPS.
2. New Franchisees or their Managers are initially trained at the premises licence holders Head Office and at the company-owned store in Sandbach. The training encompasses management, sales and dealing with age-restricted goods. This is complemented by a training guide, which can be used for reference.
3. All staff who come face to face with the public should be trained using the premises licence holders Distance Training Package and DVDs. This is a one month course after which, the member of staff is signed off by their trainer. There are examinations at the end of each week and the member of staff must complete each weekly module. Additional questions are produced on a quarterly basis, so that training is ongoing.

Prevention of Crime and Disorder

The premises licence holder maintains a 21 Policy. The object is that any person who appears to be under the age of 21 years will be asked for identification before alcohol is sold to them. The only acceptable forms of identification are those which contain both a date of birth and a photograph.

Passport, photographic driving licence or a PASS approved Proof of Age Card.

The premises licence holder offers a reward for persons who give information which leads to the conviction of adults who are purchasing alcohol and then supplying it to people under the age of 18.

The shop and storage areas will be extensively alarmed under a monitored system. This will include a personal attack alarm button sited in the till and store areas. All doors and windows will be included in the alarm system.

A multi CCTV system will be installed covering the sales and till areas. The cameras will be linked to a recording system and images will be made available to the police on their request.

Roller shutters are installed at the premises for out of hours use.

It is proposed that in addition to the DPS, a number of full-time and part-time staff posts will be created. This will ensure that there are always two personnel on duty in the shop after 6.00 pm.

No shop assistant under the age of 18 will be employed to serve alcohol.

Public Safety

If reasonable recommendations are made by the fire service, these will be complied with.

Prevention of Public Nuisance

No matters relating to the prevention of public nuisance have been identified by the applicant in preparing this application.

Protection of Children from Harm

The premises licence holder maintains a 21 Policy. The object is that any person who appears to be under the age of 21 years will be asked for identification before alcohol is sold to them. The only acceptable forms of identification are those which contain both a date of birth and a photograph. Passport, photographic driving licence or a PASS approved Proof of Age Card.

The premises licence holder offers a reward for persons who give information which leads to the conviction of adults who are purchasing alcohol and then supplying it to people under the age of 18.
