The Prevention of Public Nuisance

I, along with many residents of Brimington do not believe there is just cause for the license extension.

The Ark Tavern continues to be a public nuisance since the last extension. Live music is played at exceptionally loud volumes which leaks straight from the pub. This is because the Landlord is not adhering to guarantees that were given during the last hearing namely:

- shutters not used during live performances
- windows open during live performances
- doors open during live performances

These points were raised with Noise Control over the May Bank Holiday weekend,

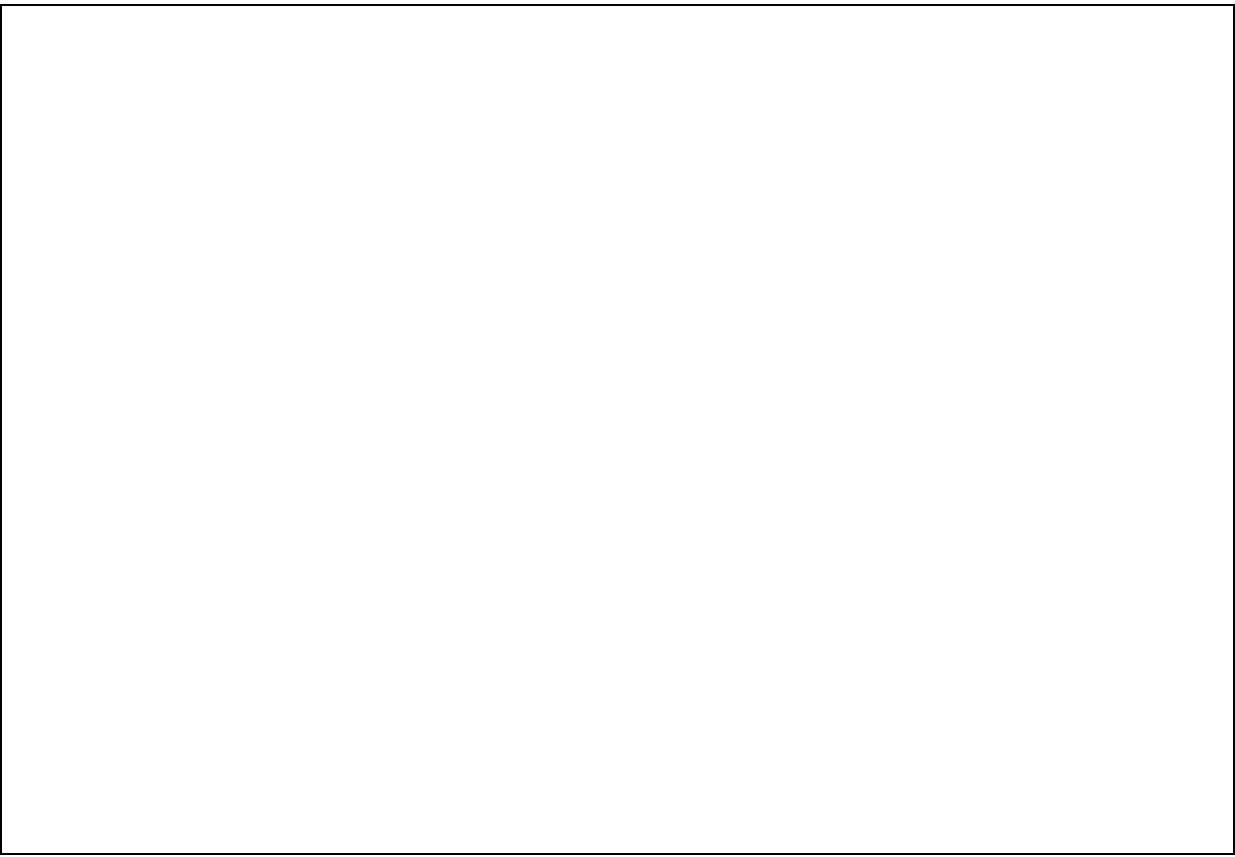
however, they neglected to respond back to me directly.

Further to the continual noise issues emanating from the Ark Tavern, I am very concerned by the number of teenagers that congregate in and around the Ark Tavern exhibiting anti-social behaviour. In the application there is conflicting information relating to this, in section L it states no persons under the age of 18 will be on the premises after 21:00 but in section M point (e) relating to the protection of children from harm it states there will be no persons under the age of 18 will be on the premises after 22:00. I have frequently observed teenagers both in the beer garden and coming from the front doors after both of these times. Often these teenagers look to be in a state of inebriation and cause a nuisance around the premises and on the road.

This application to serve alcohol into the early hours of the morning each day of the week seems completely out of character for a small village pub in a conservation area and unjustifiable when viewed with the other issues that are caused by the Ark Tavern.
