Consent is refused to crown reduce of T14 London Plane in height, but consent is granted to reduce branches growing towards the building to give a 2 metre clearance from the structure and clear one lighting head. Consent is also granted to dead wood and crown lift the 14 trees to clear the highway.
CHE/20/00803/TPO TPO 4901.244 17/12/20	The felling of one diseased and dangerous Ash tree within G1 on the Order map for Mr Paul Scragg on behalf of Norbriggs Primary School, Worksop Road, Mastin Moor.	Consent is granted to the felling of one Ash tree. The duty to plant a new tree has been dispensed with on this occasion due to no loss of amenity within the group of trees.
CHE/20/00747/TPO TPO 4901.159 18/12/20	The felling of one Silver Birch tree within G2 and the pruning of one Beech reference T18 on the order map for Ascent Tree Solutions for 668 Chatsworth Road.	Consent is granted to the felling one diseased and dangerous Birch tree within G2 with a condition to plant a new Birch tree in the next available planting season after felling. Consent is refused to the crown reduction of one Beech tree as this will not solve the alleged light issues. Consent is however, granted to crown thin the tree and selectively

		prune branches growing towards the property which is a more acceptable operation to allow light to filter through the crown into the garden.

Consent is granted to the felling of one Poplar tree with a condition to plant one new Oak tree as near as is reasonably possible to the original tree.
CHE/20/00766/TPO TPO 4901.335 21/12/20	The pruning of one Sycamore tree reference T1 on the order map for Valleyside Landscapes Ltd on behalf of Brampton Primary School, Brampton.	Consent is granted to the crown thinning of one Sycamore tree by 20% and to include the selective pruning of branches growing towards the property.
CHE/20/00817/TPO TPO 4901.172 08 /01/21	The felling of 4 Pine trees reference T12, T14, T15 & T16 on the Order map for PRI Ltd on behalf of 406 Old Road, Ashgate. The trees are allegedly causing subsidence to the property.	Consent is refused to the felling of 4 Pine trees because insufficient information has been provided with the application. There is no evidence to support the claim that all the trees are causing the alleged damage. Level monitoring has been carried out although the datum point used may be unreliable and could give false readings. The Arboricultural report and recommendations are based on the Engineers report, however the Engineer report was produced after the Arb report so it is unclear how this could have been

		assessed when no information was available.

Consent is refused to the felling of T59 Beech because no supporting evidence has been provided to justify the trees removal. Consent is granted to the felling of one Poplar tree reference T60 which is clearly causing damage to the driveway by lifting the tarmac along the trees rooting system and damaging the stone boundary wall. Although no structural report was provided with the application it is clear from the tree species, closeness to the wall and driveway and on-site observations that it is the tree causing the damage.

Consent is refused to the reduction of the crown by 40% and a crown thin by 40% because the works proposed are not good arboricultural practice and exceed the recommendations within BS3998 Tree Works 2010. The reduction of the tree by

		<p>40% would leave the tree unsightly and drastically reduce its amenity value. The tree was pruned less than 2 years ago and has only put on 1 metre of new growth which is clear of properties and open in structure.</p> <p>Consent is granted to remove dead wood and any new growth within the crown.</p>

<p>CHE/20/00815/TPO TPO 4901.7 14/01/21</p>	<p>The felling of 4 Pine trees within G2 on the Order map for PRI Ltd on behalf of 392 Ashgate Road, Ashgate. The trees are allegedly causing subsidence to the property.</p>	<p>Consent is refused to the felling of 4 Pine trees because insufficient information has been provided with the application and other trees where roots were found in the trial pits have not been assessed or recommended for removal.</p> <p>There is no evidence to support the claim that all the trees are causing the alleged damage. Level monitoring has been carried out and it appears the property may be settling. Leaking drains have been repaired but the results of this are unknown so should be assessed further.</p>

The tree is considered to be in a sound condition with no visible defects and contributes to the group as a whole unit and its amenity value.</p> <p>Consent is also refused to the removal of limbs overhanging the shed of the neighbouring property and the pollarding of one Willow tree when other more sympathetic pruning operations are available to alleviate the perceived problems.</p> <p>Consent is granted to crown reduce the Willow tree by a maximum of 4 metres back to previous reduction points, crown lift the tree to 5.2 metres and a light thin by 10% to remove some of the leaf density. Consent is also granted to crown lift the Sycamore tree to clear the low branches overhanging the shed.</p>
