



USE A TYPE OF GLASS THAT DOESN'T GET THE BUILDING REALLY HOT. THE CURRENT CAFE AREA GETS REALLY UNPLEASANT IN THE SUMMER, MAYBE HAVE WINDOWS THAT OPEN COMPLETELY, FRENCH DOOR THINGS? OUTSIDE SEATING AREA WITH SUNSHADES, LOTS OF TREES AND PLANTED AREAS OUTSIDE TO HELP THE SITE BLEND INTO THE PARK BACKGROUND. GOOD SIGNAGE ALONG THE ROAD. GENERALLY THE PLANS ARE GOOD AND WILL MAKE A REFRESHING CHANGE FROM WHAT IS CURRENTLY PROVIDED. EXCELLENT SIGNAGE NEEDED. (DUE TO CENTRE NOW BEING SET BACK FROM THE ROAD) BEING A USER OF DERBYSHIRE DALES ARC SWIMMING FACILITIES, I FEEL THE PROPOSED DESIGN AND LAYOUT WILL BE FIT FOR THE PURPOSE INTENDED. CONSERVING ENERGY AND A NON INTRUSIVE DESIGN ARE EXCELLENT POINTS THOUGHT OF IN THE CONSTUCTION. WARMER IN WINTER, MORE NATURAL LIGHT, JUST WHAT ONE WOULD EXPECT FROM A MODERN LEISURE CENTRE. IF MOST PEOPLE ENTER THE SITE FROM BOYTHORPE ROAD. WILL THEY BE ABLE TO SEE THE ENTRANCE EASILY. IF NOT, THEN MAKE SURE THERE IS ADEQUATE SIGNAGE TO DIRECT THEM TO THE ENTRANCE. CLOSE BOYTHORPE AVENUE AND USE THE NATURAL FALL OF THE LAND TO PROVIDE A TWIN LEVEL SPORTS CENTRE, PART ON THE ANNEX AND PART USEING THE SLOPE DOWN FROM THE ANNEX ONTO BOYTHORPE AVENUE. AN ACCESS BRIDGE LINKING THE NEW SITE TO QUEENS PARK! THE TRIM TRAIL (FUNDING PERMITTING) SHOULD ENCAPSULATE THE ENTIRE SITE TO TAKE ADVANTAGE OF THE WEALTH OF BOTANICAL INTEREST THAT IS PRESENT. THE TRAIL SHOULD INCORPORATE 'RELAXING AREAS' WITH BENCHES AND SEATS IN SHADDY AREAS WHERE PEOPLE CAN OBSERVE WILDLIFE E.G. STRATEGICALLY LOCATED BIRD FEEDERS. I WOULD LIKE TO SEE A RAISED 'YOUNG EXPLORERS' AREA THAT INCORPORATES A WILDLIFE POND THE OVERAL LOOK OF THE PLACE IS NICE.HOWEVER.I DON'T THINK THE PARKING AREA IS NOWHERE NEAR BIG ENOUGH.CONSIDERING HOW MANY PEOPLE WILL USE IT.I TAKE IT THAT THE OLD CAR PARKS AT THE QUEENS PARK SITE WILL STILL BE OPERATIONAL?ALBEIT, A BIT OF A TREK!ANOTHER ISSUE FOR ME IS THAT BEING PART OF CHESTERFIELD SWIMCLUB AND ON THE COMMITTEE,I HAVE A CONCERN.AS DO MANY OF THE CLUB MEMBERS. AS TO WHERE THE VIEWING GALLERY IS FOR SWIMMING.AS A COMPETITIVE CLUB.WE HOST GALAS.THERE'S NO WAY ANYONE CAN SPECTATE!THE REVENUE THESE GALAS BRING IN IS AMAZING.AND WE PRIDE OURSELVES IN BEING ABLE TO DRAW CLUBS IN FROM FAR AND WIDE!NOT NO MORE! GENERALLY IT IS OK, MY ONLY CONCERN IS THE POSITION OF THE MAIN ENTRANCE IS IN A BAD LOCATION DUE TO THE HILL, ALSO THE DWELLINGS DIRECTLY ACROSS THE ROAD WILL HAVE HEAD LIGHT POLLUTION FROM THE CARS EXITING THE NEW CENTRE AFTER IT GETS DARK + POSSIBLE PARKING DIFFICULTY DUE TO CARS UNDERTAKING ANY TRAFFIC THAT IS WAITING TO ACCESS THE SITE. MY SOLUTION WOULD BE TO LOCATE THE MAIN ENTRANCE ON BOYTHORPE AVENUE ON ACROSS FROM THE QUEENS PARK SIDE ENTRANCE.. BEING A LOT QUIETER RD PLUS THERE ARE NO RESIDENCIAL DWELLINGS TO TAKE INTO CONSIDERATION WHEN PUSHING THROUGH THE FINAL PROPOSAL / DRGS. I THINK IT HAS ALREADY BEEN WELL THOUGHT OUT TO SHOW CONSIDERATION FOR THE CONSERVATION AREAS AND THE PARK'S SURROUNDINGS. I FEEL IT IS VERY IMPORTANT THAT THE NEW DEVELOPMENT DOES NOT EXCEED THE HEIGHT OF THE SURROUNDING TREES OR REMOVE ANY OF THEM! HAS CONSIDERATION BEEN GIVEN TO THE SURROUNDING HOMES I THINK THE ENTRANCE/EXIT ON TO BOYTHORPE ROAD WILL PROVE TO BE PROBLEMATIC. IT IS A VERY BUSY ROAD WITH POOR TRAFFIC MANAGEMENT AND I FEEL THAT EXITING THE CENTRE IN PARTICULAR WILL PROVE TO BE DIFFICULT

I THINK THAT THE IDEA OF INSERTING A CONTEMPORARY BUT RESPONSIVE DESIGN IN THIS SETTING IS A GOOD ONE. CONSIDERATION TO ENVIRONMENTAL RESPONSE IS WELCOME BUT ALONGSIDE THIS I DO HOPE THE CENTRE CAN SEEK TO REPLICATE SOME OF THE POSITIVE ASPECTS THAT THE EXISTING CENTRE HAS, AND WHICH HAS KEPT US RETURNING EVEN THOUGH IT IS IN A SAD STATE OF REPAIR. WITH REGARD TO LOCATION AND ORIENTATION MY ONLY CONCERN IS THE MISSED OPPORTUNITY FOR A CAFE OVERLOOKING THE PARK. WE REGULARLY ENJOY GOING TO THE EXISTING CAFE WITH ITS RAISED ASPECT. SURELY THERE IS SOME REVENUE TO BE GENERATED HERE RATHER THAN JUST FACING A CAR PARK? THE DRONFIELD SPORTS CENTRE CAFE IS SOULESS FOR THIS REASON. POSSIBLY MAKE MORE USE OF THE SOUTH PART OF SITE.

WOULD THE ENTRANCE WAY BE BETTER ACCESSED THROUGH BOYTHORPE AVENUE RATHER THAN ON THE BUSIER MAIN ROAD AS IS NOW?ALSO BE BENEFITICIAL TO INTERGRATE THE CURRENT QUEENS PARK SITE OPPOSITE MORE RATHER THAN CUT OFF FROM IT AS APPEARS ON THE SITE PLAN.

THE CURRENT PLAN DOCUMENT DOESN'T MENTION THE FOLLOWING ITEMS: - 1: WHAT IS PROPOSED FOR THE POTENTIAL FOOTBALL AND ATHLETIC AREAS IF THEY DON'T GO AHEAD, E.G. WILL THE AREAS BE GRASSED? 2: WILL THE FOOTBALL AND ATHLETIC AREAS HAVE FLOODLIGHTS. 3: THERE IS NO MENTION OF SECURITY. THERE IS A PROBLEM WITH SECURITY AND VANDALISM IN THE ANNEXE AT PRESENT. WILL THERE BE A PERIMETER FENCE? WILL THE WHOLE AREA BE CLOSED OVERNIGHT?

TO HELP THE CURRENT WILDLIFE CREATE WILDLIFE CORRIDORSTHAT ALLOW TRANSITION ACROSS THE AREA. FOR EXAMPLE BETWEEN THE POTENTIAL TRIM TRAIL AND THE BACKS OF HOUSES ON SUMMERFIELD ROAD, DOWN BOTH EAST AND WEST SIDES OF THE AREA AND BETWEEN THE NEW DEVELOPMENT AND THE EXISTING BOWLING GREEN AND TENNIS COURTS.

General comments

- Why wouldn't people be for it? Staveley has a new one, we deserve one. All for it.
- I currently use the Arc as it has better facilities. I would like to visit a local centre, and am supportive of the development.
- Looking forward to the new centre the current one is old and tired.
- In favour of the new centre.
- Excellent idea for new complex.
- Go for it the more people we can get into sport the better.
- I was under the impression that QPSC was closing.
- Get on with it. Queen's Park Sports Centre is beyond refurbishment. The old site would need to be shut down for a long period if refurbished.
- I didn't know that CBC was building a new centre. I thought that QPSC was just being shut down. Glad it's staying open until the new one is built.
- Glad that the current centre is staying open whilst the new one is ready.
- QPSC has had it! The changing facilities are really bad. The ceilings of the pool look like they have had it.
- Everywhere is very dirty at QP now
- We used to use Queen's Park Sports Centre but it got too dirty we are pleased about the new plans.
- I would like a local referendum on whether to rebuild or refurbish full vote. You state your case, we state ours then we can move forward.
- My only concern would be the accessibility and availability of the facilities for the public in light of the large stake Chesterfield College will apparently have in the new building, which has not been mentioned on the information boards!

Comments about the site

- Happy that the alternative site has been chosen as it means QPSC can stay open until the new one is ready.
- The Annexe has been empty for years, it's about time something useful was done with it. I'm interested to know what will happen with the old site though.
- Like the idea of a trim trail. They are really popular natural fitness and it's free. They work really well at other parks.
- Only the number 17 bus goes past. Are there any other ways of transport from the town centre?
- Annexe there is an embankment where the pools will be going worried about the weight of the water. Should be built along the football pitch rather than across.

- The old Sports Centre site needs to be developed in a way that does not detract from the beauty of Queen's Park i.e. not a large concrete car park.
- What is going to happen to the existing site?
- Existing centre needs to be involved in leisure/park. Not happy for big buildings or potential housing. Pedestrian access to be revised, maybe one on Boythorpe Avenue to make the park easier for access.

Comments about the facilities

<u>Poolside</u>

- Like the idea of the children's water feature and moveable floor in the children's pool. Doesn't like the current flume it's tacky so not bothered about it going. Good stuff.
- Want to use QPSC but have use HLC pool as QPSC pool is not accessible for disabled people. Need to have a similar hoist arrangement as at HLC.
- Swimming lessons would like a viewing platform for parents so we can communicate and encourage children.
- I think we should have a spray fountain in the children's play area in Queen's Park. There is a lack of seating for adults, who have to stay sat nearby. Every town I visit has these somewhere even in the market square. Please would you bear this in mind. With money being very short, a facility where children can enjoy homemade picnics etc. is much needed.
- You are missing a trick there is a gap in provision for 5-14 year olds for water fun to attract tourism. There should be
 information about the leisure centre at the Tourist Information Centre.
- Some way of being able to communicate with children whilst they are on swim lessons, also steps into pool. Everything else seems okay and very positive, brilliant.
- As we use Queen's Park Sports Centre for swimming facilities. Where are the viewing galleries going to be for water sport event competitions? Also where are the electronic scoreboard/electronic timing equipment going to be run from for water based competitions? Swimming/water polo are very popular sports!
- Swimming pool too short.
- 25 meter pool is too short.
- Pool size in the new centre is a concern, would prefer a bigger pool.
- We want diving boards.
- We regularly travel from Matlock, especially in the school holidays to use the swimming facilities and the diving boards are the biggest attraction plus the ability to jump and dive in the specific area, it would be such a shame not to have this facility and without it, it would be no better than the ARC which the boys tell me its boring and they don't want to go there!

- The present Queen's Park facility requires greatly improved refreshment facilities very important. The present set up is abysmal. Male changing facility cleanliness poor, organisation poor. Staveley Healthy Living Centre much better on both counts.
- Really like the black brick option, and the coffee shop style café we spend a lot of time in the centre go for a swim then food.
- Nuneaton has a very good learner pool, with fun water features and a reasonable family rate.

Café and social areas

- Please make sure the legs don't fall of the chairs like the ones in the staff room at Town Hall.
- Please ensure the toilets are closer to the eating and play area. Unlike Staveley not helpful when you have to walk to the other end of the centre.

Other

- You need a better climbing room or bouldering (like Wirksworth) for more experienced climbers, not half done like Staveley.
- Hope the entrance is better thought out than HLC and that more attention is paid to the changing facilities.
- Please include children's indoor play area/climbing frames.
- Showering facilities at HLC are a disgrace, as is the entrance and exit system.
- I favour the sustainable features heating, grey water etc.
- Would you consider doing kettle bell sessions?
- Kettle bell classes are increasingly popular and other gyms would love to join as a DD member along with friends if this was taught here.
- Would like to do kettle bell classes
- Would like to have kettlecise classes.
- Have you considered gym equipment that generates electricity?

APPENDIX 4: Notes of Accessibility Meeting 6th August 2013

Members of the Chesterfield Equality and Diversity Forum, and other local groups with a specialism in accessibility were invited to the accessibility meeting, where the architects explained the proposals, took the queries and opinions of around 20 participants.

Summary of discussion points and questions

- What facilities are there for disabled changing?
- Is the Changing Places facility going to be open to use by café and park visitors or swimmers only?
- Are you going to have a movable or tracking hoist for access into the pool?
- If it is not a Changing Places facility, then this might be a backwards step for Queen's Park Sports Centre
- Within the village change, is there provision for larger family change cubicles for people who don't need the hoist etc?
- I think it is important that it is labelled 'Changing Places' so that people know they can access the facility.
- How do you get upstairs?
- Is the pool water at deck level?
- How long does it take to move the learner pool floor?
- Will there be something on the glass wall to stop people walking into it?
- Consider which finger grips would be best for people with visual impairment
- Is there space to park a scooter?
- Did you use the Sports England Accessibility Guide?
- Please can you make sure that the hearing loops are in the right place and not near noisy equipment
- Please can you include flashing beacons as well as the sound alarm for people with hearing impairments
- What are the temperatures in the two pools?
- If the car park is full, is there still adequate space for emergency vehicles?
- Will the car parking be sufficient for the plans for future developments?
- Will you be landscaping the rest of the annexe?
- Does the new centre have solar panels?
- Can the old solar panels be moved before the existing centre is closed?
- Will the centre be open to the public all of the time?
- Is there a commitment and drive to get more people into the new centre many have stopped using QPSC.
- What will happen to the existing athletics track?
- When will the new centre be ready?
- Is the consultation available in alternative languages and large print?
- Can we see the plans again before formal planning process?

APPENDIX 5 - FURTHER COMMENT SUBMITTED BY EMAIL

The Annexe is an early 20th C facility adjoining, and perhaps in the future more closely attached, to a Victorian, grade II listed park. The housing surrounding it is late 19th early 20th C. Although the design would fit in well next to Debenhams, it is quite inappropriate for this site.

Chesterfield is a red brick town – grey bricks are inappropriate. The design of the new medical centre at the top of Foljambe Road had to be changed to incorporate red bricks.



The present Sports Centre is reasonably attractive when seen from Queen's Park. Users of the outdoor facilities in the Annexe will be confronted by a grey brick wall and the residents of Summerfield Road will be confronted by two brick walls and a flat roof. Although the view is screened when the trees are in leaf, in winter they will get full benefit of the unattractive view.

According to the report 'Full height glazing to the north and west elevations will ensure excellent levels of day lighting and allow unobstructed views of the surrounding landscape. The view to the west is of the car park and to the north is restricted by the trees bounding the Annexe! I assume that the building is this way round to reduce the light pollution for the residents on Summerfield Road otherwise why would the area which uses artificial light, i.e. the sports hall, be on the side which benefits most from natural light and the area which would benefit from natural light is on the north side of the building. This has implications for energy demands for both lighting and heating.

The original consultant's report said that the contribution from solar power was 3-4% but this is in a building which is energy inefficient. If the energy efficiency is increased the potential proportion available from solar power will also increase. The consultation document says

that solar power is being considered but a flat roof would require additional framework to optimise the efficiency of the panels. A pitched roof as on the present Sports Centre is better than a flat roof and is more attractive.

There is provision for people to view activities in the sports hall but what about the swimming pool when there are competitions on, or is it no longer able to host competitions? The café is not a good place to watch races.

Personally I do not use the leisure centre, but friends I have spoken to all say that they regret the reduction in size of the pool as they use it for fitness swimming. I have encouraged them to fill in the survey. If the size of the pool is reduced they will probably go elsewhere – why put up with overcrowding if they can use the same size pools in the other gyms in the town?

The proposed site plan does little to provide much needed facilities for teenagers to combat the anti-social behaviour prevalent in the area. The most popular request for additional facilities was for athletics. The proposed athletics facilities are inadequate and the football pitch will be unused for much of the year. A better idea would be to replace it with a MUGA and use the space saved to enhance the athletics facilities. There are additional football pitches available in the town but limited athletics. Both facilities could be used every day throughout the year. I have no real problem with use of the facilities being shared with the college. I would have thought that with cooperation, common sense and a bit of give-and-take then conflict could be reduced to a minimum. One possible area of conflict is the use of the present MUGA but provision of a second one would reduce that. The MUGA and the athletics facilities could be used by Sporting Futures and the churches project for work with youngsters.
